# I. Election of Chairman and Deputy Chairman for the 2020-2021 session

#### Election of Chairman

Mrs Regina IP, incumbent Chairman, advised that 25 members had written to the Secretariat indicating not to accept nominations to the positions of Chairman and Deputy Chairman of the Panel on Education ("the Panel"). The letters had been e-mailed to all Members via e-mail on 15 October 2020 (LC Paper No. CB(1)15/20-21). The list of 25 members had been tabled for members' information.

- 2. <u>Mrs Regina IP</u> said that according to the judgement of the case of *LEUNG Kwok Hung v The President of the Legislative Council of the Hong Kong Special Administrative Region* (CACV123 of 2012), members presiding over meetings had the power and function to exercise proper authority or control to ensure that the meetings be conducted in an orderly manner. As such, she would allow members 15 minutes to make nominations for the chairmanship of the Panel with a view to completing the election at today's meeting.
- 3. <u>Mrs Regina IP</u> called for nominations for the chairmanship of the Panel. Three valid nominations were made.
- 4. Dr Priscilla LEUNG was nominated by Ms YUNG Hoi-yan and the nomination was seconded by Mr CHEUNG Kwok-kwan. Dr Priscilla LEUNG accepted the nomination.
- 5. Mr IP Kin-yuen was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. Mr IP Kin-yuen accepted the nomination.

- 6. Dr Helena WONG was nominated by Mr HUI Chi-fung and the nomination was seconded by Mr Alvin YEUNG. Dr Helena WONG accepted the nomination.
- 7. <u>Dr Helena WONG</u> withdrew from the election subsequently. As there was no other nomination, <u>Mrs Regina IP</u> announced that the nomination procedure had ended. A voting on the remaining two nominations would be conducted.
- 8. <u>Mrs Regina IP</u> announced a vote by secret ballot. After all members had cast their votes, <u>Mrs IP</u> invited Ms YUNG Hoi-yan and Ms Claudia MO who had nominated the candidates to oversee the counting of votes. Of the members present for voting, 27 members voted for Dr Priscilla LEUNG and 18 voted for Mr IP Kin-yuen. <u>Mrs IP</u> declared Dr Priscilla LEUNG elected as Chairman of the Panel. Dr Priscilla LEUNG then took the chair.

#### Election of Deputy Chairman

9. <u>The Chairman</u> said that due to time constraint, the election of Deputy Chairman would be conducted at the next meeting.
