The proposed project is for the conversion works to Shatin Public School to upgrade the existing facilities and provide additional facilities to enable the special school to implement the New Senior Secondary ("NSS") academic structure and the improvement measures on the extension of years of study of students of special schools.

Hon Elizabeth QUAT in her letter dated 4 November 2020 and Hon LEUNG Che-cheung at the meeting on 6 November 2020 proposed that a comprehensive review of LS subject should be conducted and the teaching contents should be monitored. Dr Hon Junius HO in his letter dated 5 November 2020 proposed that LS subject should become an elective subject and mark submission should not be required.

The Panel discussed issues related to NSS curriculum on 15 July 2015, and LS subject on 8 June 2015 and 13 February 2017.

Dr Hon Priscilla LEUNG's letter dated 14 February 2018 concerning LS subject and the Administration's written response were issued to members vide LC Paper Nos. CB(4)715/17-18(01) and (02) (Revised version) on 9 and 16 March 2018 respectively.

Members were concerned whether the new arrangements would effectively eliminate the incentives of drilling and requested the Administration to revert to the Panel on the feedback about the new arrangements, in particular drilling in schools and the level of difficulty of TSA items.

Mr IP also considered that whole-day primary schooling should be reviewed. The subject was last discussed on 1 December 2017.

Hon IP Kin-yuen urged for early discussion of the item in his letter dated 5 November 2020.

16. Update on the implementation of "one school social worker for each school" in primary schools

In the 2018-2019 session, Hon IP Kin-yuen proposed that the Panel should be updated on the review of the mode of collaboration between student guidance and social work services under the policy of "one school social worker for each school". Hon SHIU Ka-chun requested to discuss the provision of social workers in kindergartens ("KGs") as well as primary and secondary schools.

The Administration's proposal to seek funding from the Community Care Fund for provision of subsidy to needy primary and secondary students to purchase mobile computer devices to facilitate the practice of e-learning was discussed on 2 March 2018, while issues related to the promotion of STEM education were discussed on 14 November 2016.
