| <b>1.</b> | <p><b>The Intermodal Transfer Terminal development project at the Hong Kong International Airport and the associated fitting-out works for government facilities</b></p> <p>According to the Administration, to reinforce and enhance Hong Kong's competitiveness as an international and regional aviation hub, the Hong Kong Airport Authority ("AAHK") is actively developing its intermodal facilities in order to expand the Hong Kong International Airport's intermodal connectivity. To better capitalise the opportunities brought by the Hong Kong-Zhuhai-Macau Bridge, AAHK is currently developing the Intermodal Transfer Terminal ("ITT") Project so as to provide bridge-to-air / air-to-bridge bonded bus service upon its commissioning and facilitate the travelling of transit/transfer passengers amongst Hong Kong, Zhuhai and Macao.</p> <p>To support the operation of ITT, it is necessary for the Customs and Excise Department, the Immigration Department, the Hong Kong Police Force, the Department of Health to be provided with additional facilities for the provision of customs, immigration, law enforcement, port health control and quarantine services. | <b>2.</b> | <p><b>Annual tariff reviews with the two power companies</b></p> <p>Pursuant to the Scheme of Control Agreements signed with the two power companies, the Government will conduct separate tariff reviews with the power companies each year. Thereafter, the two power companies will announce their tariffs for the following year and brief the Panel.</p>  | November 2020                             |

Member's Bill to amend the Electricity Ordinance (Cap. 406) to impose restrictions for resale of electricity to a third party, with a view to avoiding landlords of sub-divisions of flat units overcharging their tenants on the use of electricity. Hon LUK Chung-hung reiterated his request for discussion of this subject at the Panel meetings on 22 January and 22 October 2018.
