#### I. Election of Chairman and Deputy Chairman

#### Election of Chairman

Mr Steven HO, the member with the highest precedence among those who were present at the meeting, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. Mr CHAN Han-pan was nominated by Mr SHIU Ka-fai and the nomination was seconded by Mr Vincent CHENG. Mr CHAN Han-pan accepted the nomination. As there was no other nomination, Mr Steven HO declared Mr CHAN Han-pan elected as the Chairman of the Subcommittee. Mr CHAN Han-pan then took the chair.

- 3. <u>The Chairman</u> invited nominations for the deputy chairmanship of the Subcommittee. Mr SHIU Ka-fai was nominated by <u>Mr Wilson OR</u> and the nomination was seconded by <u>Mr Steven HO</u>. <u>Mr SHIU Ka-fai</u> accepted the nomination.
- 4. As there was no other nomination, <u>the Chairman</u> declared Mr SHIU Ka-fai elected as the Deputy Chairman of the Subcommittee.
