Repair requests could be made to ArchSD and EMSD via the mobile application to facilitate prompt referral of repair requests, tracking of the progress of repair works, expedite the repair process of public toilets, avoid mismatch in maintenance records and discrepancies, and systematically collate management data for</li> </ul>

For public toilets with attendant service, FEHD had instructed the attendants on duty to cleanse and disinfect the floor, water closets, urinals, wash hand basins, toilet seats, door handles, handrails, etc. every two hours with 1:99 diluted household bleach. For other public toilets, cleansing workers also carried out cleansing and disinfection at least twice daily with 1:99 diluted household bleach in performing routine cleansing service to ensure the cleanliness; and	
		<ul><li>(c) publicity efforts had also been made to advise the public to put the lid down before flushing the toilet.</li></ul>
