Impact of the Discharge of Wastewater from the Fukushima Nuclear Power Plant into the Ocean on Food Safety and Import Control on Japanese Food

At the meeting of the Legislative Council Panel on Food Safety and Environmental Hygiene held on 13 July 2021, some members requested the Administration to provide further information regarding the import of food from Japan to Hong Kong. Relevant information is set out below –

(a) Percentage share of Japan's food export to Hong Kong

According to information provided by relevant authority of Japan, among the agricultural and fishery products exported from Japan from 2018 to 2020, the percentage share in terms of the value of such agricultural and fishery products exported to Hong Kong is as follows –

2018: 23.3%

2019: 22.3%

2020: 22.3%

(b) Types, volume and value of Japanese food products imported into Hong Kong

According to the statistics of the Census and Statistics Department, the types, volume and value of Japanese food products imported into Hong Kong from 2018 to 2020 are tabulated below –
