**I. Election of Chairman and Deputy Chairman**

Election of Chairman

Mr LAU Kwok-fan, the incumbent Chairman, called for nominations for the chairmanship of the Panel for the 2020-2021 session. Mr LEUNG Che-cheung was nominated by Mr KWOK Wai-keung and the nomination was seconded by Mr CHEUNG Kwok-kwan. Mr LEUNG Che-cheung accepted the nomination.

2. Dr Fernando CHEUNG was nominated by Dr KWOK Ka-ki and the nomination was seconded by Mr Jeremy TAM. Dr Fernando CHEUNG accepted the nomination.

3. Mr KWONG Chun-yu was nominated by Mr HUI Chi-fung and the nomination was seconded by Dr KWOK Ka-ki. Mr KWONG Chun-yu accepted the nomination.

4. Mr SHIU Ka-chun was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. As Mr SHIU Ka-chun was absent, Ms Claudia MO confirmed that the nomination was accepted by Mr SHIU Ka-chun.

5. Mr HUI Chi-fung was nominated by Dr KWOK Ka-ki and the nomination was seconded by Mr Alvin YEUNG. Mr HUI Chi-fung accepted the nomination.

6. Mr Andrew WAN was nominated by Mr James TO and the nomination was seconded by Mr Alvin YEUNG. Mr Andrew WAN accepted the nomination.

7. Mr WU Chi-wai was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. Mr WU Chi-wai accepted the nomination.

8. Mr Jeremy TAM was nominated by Mr Andrew WAN and the nomination was seconded by Mr Alvin YEUNG. Mr Jeremy TAM accepted the nomination.

9. Mr LAM Cheuk-ting was nominated by Mr HUI Chi-fung and the nomination was seconded by Mr Alvin YEUNG. Mr LAM Cheuk-ting accepted the nomination.

10. Dr KWOK Ka-ki was nominated by Mr WU Chi-wai and the nomination was seconded by Mr Alvin YEUNG. Dr KWOK Ka-ki accepted the nomination.

11. Mr Charles MOK was nominated by Mr James TO and the nomination was seconded by Mr Alvin YEUNG. Mr Charles MOK accepted the nomination.

12. Mr IP Kin-yuen was nominated by Mr HUI Chi-fung and the nomination was seconded by Mr Alvin YEUNG. As Mr IP Kin-yuen was absent at the juncture, Mr HUI Chi-fung confirmed that the nomination was accepted by Mr IP Kin-yuen.

13. Mr Kenneth LEUNG was nominated by Ms Claudia MO and the nomination was seconded by Mr Alvin YEUNG. Mr Kenneth LEUNG accepted the nomination.

14. Prof Joseph LEE was nominated by Dr KWOK Ka-ki and the nomination was seconded by Mr Alvin YEUNG. Prof Joseph LEE accepted the nomination.

15. After the nomination process was completed, a total of 14 valid nominations were made. Mr LAU Kwok-fan then announced a vote by secret ballot. The result of the vote was that 26 members voted for Mr LEUNG Che-cheung, 16 members voted for Mr IP Kin-yuen. Mr LAU Kwok-fan declared Mr LEUNG Che-cheung elected as the Chairman of the Panel for the 2020-2021 session. Mr LEUNG Che-cheung then took the chair.

Election of Deputy Chairman

16. Owing to time constraint, the Chairman suggested and members agreed that the election of the Deputy Chairman would be conducted at the next meeting.

**II. Schedule of meetings for the 2020-2021 session**

17. Members agreed that the Panel would continue to hold its regular meetings on the second Monday of each month at 4:30 pm.

18. At 11:59 am, Mr WU Chi-wai drew the Chairman's attention to the fact that a quorum was not present at the meeting. The Chairman said that
