More incentives and subsidies should be provided to raise the attractiveness of the Revitalisation Scheme for Industrial Buildings ("the Revitalisation Scheme") implemented by the Transport and Housing Bureau ("THB"); (b) more support should be provided to non-government organizations ("NGOs") in resolving difficulties encountered in implementing TH projects; and (c) progress of the pilot scheme to subsidize the provision of TH through NGOs using rooms in hotels and guesthouses ("the pilot scheme"). The Administration advised that – (a) it had been actively spearheading and collaborating with NGOs on various initiatives proposed and implemented by them with a view to speeding up the provision of TH and wasted no time in taking forward TH projects;

		(b) as an example, the developer which owned the land for the large scale TH project in Kong Ha Wai, Kam Tin, Yuen Long, announced in November 2019 that it would lease the land to an NGO at a nominal rate for TH development;	
		(c) in June 2020, the project obtained TPB's temporary planning approval. It was now under construction and the first phase was anticipated to complete in end-2021 or early 2022. It was estimated that the project would only take around two years from conception to first intake of flats;	
		(d) online briefing sessions would be held in the final week of March 2021 to brief the hotels and guesthouses industry and NGOs respectively on details of the pilot scheme, with a view to receiving applications in April; and	
		(e) the Administration would draw on the experience of the first project under the Revitalisation Scheme in mapping the way forward.

		(b) the Government would not provide subsidy for NGOs' administrative expenses in addition to the amount permitted under the pilot scheme. NGOs would have to rely on the rents collected from residents of TH to pay the rent committed to the owners and their own administrative expenses; and	
		(c) construction of TH on idle sites in the New Territories required planning permission by TPB under the Town Planning Ordinance (Cap. 131), which would involve detailed environmental, ecological and transport impact assessments. For example, the TH project in Kong Ha Wai was subject to the above stringent assessments.

		(a) TC was for those who claimed to be homeless as a result of natural disasters or Government's enforcement actions. The affected persons were arranged to be accommodated temporarily in TC for three months in order to verify their claim of being homeless. During these three months, Housing Department ("HD") staff would conduct inspections to TC to ascertain whether they are genuinely homeless. If these persons had stayed in TC for three months and passed the homeless test which proved that they had no alternative accommodation, they would be arranged for admission to Interim Housing ("IH"). However, persons failing to meet the eligibility criteria (e.g. in terms of assets or income) for public rental housing ("PRH") application would be advised to leave the TC;	
		(b) the occupancy rate of TC would change from time to time depending on Government's enforcement actions and natural disasters. Currently, the occupancy rate was relatively low. In view of the COVID-19 pandemic, HD had taken a number of precautionary measures which included keeping appropriate distance between bed spaces for affected persons, distributing face masks to them and stepping up cleansing of the premises;	
		(c) there were differences in rehousing arrangements between persons living in IRS on residential buildings erected on or before 1 June 1982 and those living in IRS erected after that date. Details were set out in footnote 2 on page 2 of the Administration's paper (LC Paper No. CB(1)699/20-21(02));	
		(d) IH and PRH were scarce housing resources, and the Administration should be prudent in the allocation of housing resources. The date of 1 June 1982 as mentioned above is one of the current criteria in the rehousing arrangement; and

		The Administration noted Mr LAU's concerns and advised that Po Tin Estate in Tuen Mun had a total of about 8 700 units which comprised about 4 700 PRH units and about 4 000 IH units. Currently, there were some 800 vacant IH units which should be sufficient to meet the demand of interim housing.

	Chairman	The Chairman raised the following concerns/enquiries — (a) as occupants of illegal domestic premises in IBs were one of the most vulnerable groups affected by BD's enforcement actions, enhanced enforcement actions should be taken against illegal conversion of IBs into domestic premises which posed serious safety hazards to the occupants; (b) given that relocation allowance was currently provided under the Community Care Fund ("CCF") to occupants of illegal domestic premises in IBs, whether the Administration would consider providing relocation allowance to occupants of IRS affected by BD's operations as well; (c) more focused and people-oriented support (e.g. emotional support) should be provided by the social worker teams under BD responsible for rehousing matters; and (d) whether a family with members of both sexes was accommodated in the same place in a TC. The Administration advised that — (a) as IBs were not designed for residential purposes and posed substantial safety hazards to the illegal inhabitants, the Administration would take stringent enforcement measures against the use of IBs for domestic purpose; (b) CCF approved the launching of the Relocation Allowance for Residents of Illegal Domestic Premises in Industrial Buildings who have to move out as a result of the BD's Enforcement Action ("the Relocation Allowance") in October 2011, aiming to facilitate the timely relocation of the affected residents from the illegal domestic premises in IBs for BD to carry out enforcement action. BD and the Development Bureau were reviewing the scope of the Relocation Allowance and would report the findings of the review to CCF and the Commission on Poverty; (c) social workers team under BD would provide support to
