Action

I Election of Chairman and Deputy Chairman

Election of Chairman

Mr Charles Peter MOK, Chairman of the Panel on Information Technology and Broadcasting ("the Panel") in office, presided over the election of Chairman for the 2020-2021 session. He referred members to the letters from 24 members (issued to all Members through email vide LC Paper No. CB(1)15/20-21 on 15 October 2020) indicating that they would not accept nomination for the position(s) of Panel Chairman and/or Deputy Chairman. The relevant information was tabled at the meeting for members' reference. Mr Martin LIAO and Mr CHAN Chun-ying also indicated their wishes not to accept any nominations in the election of the Chairman and Deputy Chairman of the Panel. The Chairman then invited nominations for the chairmanship of the Panel for the 2020-2021 legislative session. A total of 7 valid nominations were made as set out in the paragraphs below.

2. Dr Junius HO was nominated by Mr CHAN Han-pan and the nomination was seconded by the Deputy Chairman. Dr HO accepted the nomination.
3. Mr KWONG Chun-yu was nominated by Mr Andrew WAN and the nomination was seconded by Mr Alvin YEUNG. Mr KWONG accepted the nomination.
4. Ms Claudia MO was nominated by Dr KWOK Ka-ki and the nomination was seconded by Mr James TO. Ms MO accepted the nomination.
5. Mr Kenneth LEUNG was nominated by Dr KWOK Ka-ki and the nomination was seconded by Dr Helena WONG. Mr LEUNG accepted the nomination.

Action

6. Prof Joseph LEE was nominated by Mr HUI Chi-fung and the nomination was seconded by Dr Helena WONG. Prof LEE accepted the nomination.

7. Mr LAM Cheuk-ting was nominated by Mr WU Chi-wai and the nomination was seconded by Mr Andrew WAN. Mr LAM accepted the nomination.

8. Dr Fernando CHEUNG was nominated by Dr KWOK Ka-ki and the nomination was seconded by Mr Andrew WAN. Dr CHEUNG accepted the nomination.

Meeting arrangements

9. As the election of chairman could not be completed within the appointed time of meeting, the Chairman concluded that he would close the meeting at this juncture, and the nomination and election would continue at the next meeting.

10. Ms Claudia MO asked whether the nominations would remain valid at the next meeting. She said that she might consider withdrawing her acceptance of nomination for the election of chairman of the Panel. The Chairman confirmed that the nominations would remain valid, and that other members could still propose other nominations at the next meeting. The Chairman added that nominees could withdraw from the election of the Chairman before balloting began.

[Post-meeting note: With the concurrence of current Chairman, members were informed vide LC Paper No. CB(1)13/20-21 issued on 16 October 2020 that the next meeting of the Panel was scheduled for Friday, 23 October 2020, from 9:30 am to 10:30 am to continue the election of the Chairman and Deputy Chairman.]
