- (b) anti-epidemic measures to be implemented by the Government to restore the economy and ease the unemployment situation;
- (c) review of the existing unemployment assistance measures and related supporting policies in Hong Kong;
- (d) reports of research studies on the unemployment assistance measures in Hong Kong;
- (e) implications of an unemployment assistance system for society, the economy and people's livelihood; and
- (f) studying the setting up of a targeted unemployment assistance system in Hong Kong and the provision of time-limited/short term unemployment subsidy in the midst of the economic downturn caused by the COVID-19 pandemic, and make recommendations.

4. <u>The Chairman</u> said that the Clerk would liaise with the Administration on the arrangements for the next meeting and members would be informed of the details in due course.
