Hong Kong-Zhuhai-Macao Bridge - funding support for Main Bridge
Supplementary Information

At the meeting of the Panel on Transport of the Legislative Council on 15 January 2021, Member requested the Government to provide supplementary information for projects related to Hong Kong-Zhuhai-Macao Bridge (HZMB) and within the Hong Kong Special Administrative Region (HKSAR) including the HZMB Hong Kong Link Road and Hong Kong Boundary Crossing Facilities projects. The information requested is set out below:

The projects related to HZMB and within the HKSAR include Public Works Programme (PWP) Item No. 844TH “Hong Kong–Zhuhai–Macao Bridge Hong Kong Link Road” and PWP item no. 845TH “Hong Kong–Zhuhai–Macao Bridge Hong Kong Boundary Crossing Facilities – Reclamation and Superstructures”. The Approved Project Estimate (APE) of PWP Item No. 844TH is HK\$25,047.2 million in money-of-the-day (MOD) prices, including a contingency sum of HK\$1,904.6 million while the APE of PWP Item No. 845TH is HK\$35,895.0 million in MOD

prices, including a contingency sum of HK\$1,584.4 million. As at end December 2020, the total expenditure of PWP Items Nos. 844TH and 845TH are about HK\$22,990 million and HK\$32,733 million respectively. Since the project accounts of PWP Items Nos. 844TH and 845TH are not yet finalized, the final expenditure, and thus the remaining amount of contingency of both PWP items could not be ascertained at this stage.
