Study of Support for Carers

Purpose

This paper briefs Members on the progress of the study of support for carers.

Existing Support Services for Carers

- 2. Labour and Welfare Bureau (LWB) implements various services and pilot schemes to assist elderly persons and persons with disabilities to live in the community. Some support services are also provided to carers of elderly persons and persons with disabilities.
- 3. Subvented community support services for elderly persons and their carers are provided through 211 District Elderly Community Centres and Neighbourhood Elderly Centres, 92 home care service teams, 88 Day Care Centres / Units for the Elderly; and around 530 respite places are available for elderly persons. Apart from these, the Integrated Discharge Support Programme for Elderly Patients, the Pilot Scheme on Support for Elderly Persons Discharged from Public Hospitals after Treatment, the Pilot Scheme on Community Care Service Voucher for the Elderly and the Pilot Scheme on Home Care and Support for Elderly Persons with Mild Impairment also provide community support for elderly persons and their In view of foreign domestic helpers (FDHs) playing the role of primary carer of elderly persons in many families, the Government has also implemented the Pilot Scheme on Training for Foreign Domestic Helpers in Elderly Care to better equip FDHs with skills to care for elderly persons, thereby enhancing their quality of life in the community and supporting their ageing in place.
- 4. Subvented community support services for persons with disabilities and their carers are provided by 19 Parents/Relatives Resource

Centres, 17 Social and Recreational Centres for the Disabled, 16 District Support Centres for Persons with Disabilities, 5 Support Centres for Persons with Autism, 8 service teams for Home Care Service for Persons with Severe Disabilities and Integrated Support Service Teams for Persons with Severe Physical Disabilities; and around 490 respite service places are available for persons with disabilities.

- 5. In addition to the above, the Pilot Scheme on Living Allowance for Carers of Elderly Persons from Low-income Families and the Pilot Scheme on Living Allowance for Low-income Carers of Persons with Disabilities respectively provide financial support to eligible carers of elderly persons and carers of persons with disabilities. The Pilot Scheme on Providing Subsidy for Higher Disability Allowance Recipients in Paid Employment to Hire Carers provides a subsidy for eligible persons with disabilities to hire carers to assist them in travelling between their homes and workplaces, with a view to encouraging them to stay in employment.
- 6. The above support services for carers include providing carers with information, training service, counselling service, outreaching service, assistance to form mutual assistance groups, demonstrations and loans of rehabilitation equipment, cash support, as well as providing eligible elderly persons and persons with disabilities in need with home-based or centrebased care services, residential respite services and day respite services.

Study of Support for Carers

7. With an ageing population and changes in social environment, the number of carers and support services needed are expected to increase. To address this, LWB has launched a study on support for carers to explore more thoroughly the needs of carers and formulate a more comprehensive policy. LWB has commissioned a multi-disciplinary consulting team of the Hong Kong Polytechnic University to assist in carrying out the study. The consulting team will seek to understand from carers, service providers, professionals and other stakeholders the needs and service expectations of carers of elderly persons and persons with disabilities. The consulting team will also analyse carer policies and support services of other economies and consider various factors including finance, feasibility and sustainability in order to put forward recommendations on support for carers.

Progress of Study

8. The consulting team is currently conducting data collection and analyses for the study on support for carers. The study and recommendations are expected to be completed in 2021. An overview on the study of the consulting team is at the **Annex**.

Stage 1 is a qualitative research, Stage 2 is a cross-sectional survey (quantitative research), and Stage 3 is another round of qualitative research.

Studies 5 and 6

Aim:

► To develop a typology of normative needs and service expectations of carers of elderly persons (Study 5) and of carers of PWDs (Study 6) from the perspective of stakeholders

Design:

3-stage mixed method approach

Stage 1 is a qualitative research, Stage 2 is a cross-sectional survey (quantitative research), and Stage 3 is another round of qualitative research.

Aims:

► To explore financial support for carers of elderly persons, including the way forward of "Pilot Scheme on Living Allowance for Carers of Elderly Persons from Low-income Families"

Aims:

► To assess the effectiveness of the two pilot schemes, namely Special Care Subsidy for the Severely Disabled, and Pilot Scheme on Providing Subsidy for HDA Recipients in Paid Employment to Hire Carers

► To explore the way forward of these two pilot schemes and the Pilot Scheme on Living Allowance for Low-income Carers of Persons with Disabilities in coordination with other existing or pilot services
