(b) wider application of technology, for example, the introduction of a multi-purpose card for the elderly to facilitate their access to various public services and welfare benefits, to enhance the quality of life of elderly persons and promote "ageing in place".

6. <u>The Chairman</u> said that he would follow up the issues suggested by members with the Administration in order to better tie in with the implementation of the work plan of the Subcommittee. Members would be informed of the arrangements for the next meeting in due course.
