

**L.N. 232 of 2020**

**Airport Authority Ordinance (Map of Restricted Area)  
(Amendment) Order 2020**

(Made by the Director-General of Civil Aviation under section 37 of the Airport Authority Ordinance (Cap. 483) after consultation with the Airport Authority)

**1. Commencement**

This Order comes into operation on 29 January 2021.

**2. Airport Authority Ordinance (Map of Restricted Area) Order amended**

The Airport Authority Ordinance (Map of Restricted Area) Order (Cap. 483 sub. leg. L) is amended as set out in section 3.

**3. Schedule amended (Restricted Area)**

(1) The Schedule, section 1(a)—

**Repeal**

everything after “shown”

**Substitute**

“coloured green in the map described as “Airport Authority Ordinance (Cap. 483) Map of the Restricted Area” and numbered AAO/RA/001 (Revision K);”.

(2) The Schedule, section 1(b)—

**Repeal**

everything after “shown”

**Substitute**

“coloured yellow in a set of 9 maps each of which is described as “Airport Authority Ordinance (Cap. 483) Map of the Restricted Area” and respectively numbered—

- (i) AAO/RA/002 (Revision I);
- (ii) AAO/RA/003 (Revision I);
- (iii) AAO/RA/004 (Revision I);
- (iv) AAO/RA/005 (Revision J);
- (v) AAO/RA/006 (Revision J);
- (vi) AAO/RA/007 (Revision J);
- (vii) AAO/RA/008 (Revision H);
- (viii) AAO/RA/009 (Revision E); and
- (ix) AAO/RA/010 (Revision E);”.

- (3) The Schedule, section 1—

**Repeal paragraph (c)**

**Substitute**

“(c) parts of the SkyPier ferry terminal of the Airport that are delineated and shown coloured blue in the map described as “Airport Authority Ordinance (Cap. 483) Map of the Restricted Area” and numbered AAO/RA/011 (Revision D); and”.

- (4) The Schedule, after section 1(c)—

**Add**

“(d) parts of the automated people mover depot of the Airport that are delineated and shown coloured orange in the map described as “Airport Authority Ordinance (Cap. 483) Map of the Restricted Area” and numbered AAO/RA/012 (Revision A).”.

(5) The Schedule, section 2—

**Repeal**

everything after “signed by”

**Substitute**

“the Director on 23 November 2020 and kept by the Authority.”.
