### **Explanatory Note**

These Rules amend the Foreign Lawyers Registration (Fees) Rules (Cap. 159 sub. leg. U) (*principal Rules*) to revise the fees payable to The Law Society of Hong Kong in connection with—

- (a) the first registration as a foreign lawyer or foreign firm; and
- (b) the renewal of a certificate of registration as a foreign lawyer or foreign firm,

under Part IIIA of the Legal Practitioners Ordinance (Cap. 159), with effect from 1 July 2021. The fees will be adjusted with effect from 1 July 2022.

- 2. As no firm is eligible to rely on item 2(a)(ii) of the Schedule to the principal Rules, the item is repealed.
- 3. These Rules introduce a three-tier fee mechanism for the first registration as a foreign firm to align with the three-tier fee mechanism for the first registration as a foreign lawyer.
