Explanatory Note

These Rules amend the Criminal Procedure (Witnesses' Allowances) Rules (Cap. 221 sub. leg. B) to increase the maximum rates of allowances for the following classes of witnesses in criminal proceedings—

- (a) witnesses practising specific professions who give professional evidence;
- (b) expert witnesses who give expert evidence;
- (c) witnesses who give evidence (other than professional or expert evidence) and lose remuneration or incur expenses as a result.
