Council meeting on 14 December 2022

**Amendments to Hon CHAN Yung's motion on
"Comprehensively understanding the country's development and
telling good stories of China and Hong Kong, China"**

Further to the email (LC Paper No. CB(3)862/2022) issued on 1 December 2022, the President has given permission for Hon YIM Kong and Hon TANG Ka-piu to move amendments to Hon CHAN Yung's motion, and has directed that the amendments be printed in the terms in which they were handed in on the Agenda of the Council.

2. The President will order a joint debate on the above motion and the amendments. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Members who wish to move amendments to the motion to speak in the following order, but no amendment is to be moved at this stage:
 - (i) Hon TANG Ka-piu; and
 - (ii) Hon YIM Kong;
- (d) call upon the public officer(s) to speak;

- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendments;
- (g) call upon the public officer(s) to speak again;
- (h) deal with the amendments in the order set out in paragraph (c) above, i.e. first invite the mover of the first amendment to move the amendment and forthwith propose and put to vote the question on the amendment, and thereafter proceed to deal with the remaining amendment(s); and
- (i) after all amendments have been dealt with, call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

4. Members are reminded that in accordance with Appendix IIIA to the House Rules, the **maximum duration of this joint debate (including voting) is four hours**. The motion mover will have a total of 10 minutes to make introductory speech and reply (paragraph 2(a) and (i) above refers), and another five minutes to speak on the amendment(s) (paragraph 2(f) above refers). The mover(s) of the amendment(s) and other Members may each speak once up to a maximum of five minutes.

**Motion debate on
“Comprehensively understanding the country’s development and
telling good stories of China and Hong Kong, China”**

1. Hon CHAN Yung’s original motion

That this Council urges the Government to promote public understanding of the country on all fronts, including the country’s fundamental systems and constitutional system, the history and mission of the Communist Party of China, as well as the country’s strategies to cope with global changes of a magnitude not seen in a century and to realize the great rejuvenation of the Chinese nation; at the same time, the Government should strengthen the education and promotion of Chinese history, the history of the War of Resistance in Hong Kong, China and Chinese culture, so as to enable the public to have a comprehensive understanding of the good stories of China and Hong Kong, China, thereby enhancing the sense of identity among the public towards the country and Hong Kong.

2. Motion as amended by Hon TANG Ka-piu

That *since the enactment of the Hong Kong National Security Law and the improvement of the electoral system, Hong Kong has embarked on a new journey of transition from chaos to order and advancing from stability to prosperity; in the new era*, this Council urges the Government to promote public understanding of the country on all fronts, including the country’s fundamental systems and constitutional system, the history and mission of the Communist Party of China, as well as the country’s strategies to cope with global changes of a magnitude not seen in a century and to realize the great rejuvenation of the Chinese nation; at the same time, the Government should strengthen the education and promotion of Chinese history, the history of the War of Resistance in Hong Kong, China and Chinese culture, so as to enable the public to have a comprehensive understanding of the good stories of China and Hong Kong, China, thereby enhancing the sense of identity among the public towards the country and Hong Kong; *this Council also urges the Government to take measures to urge all government departments, government-subsidized educational and social service units as well as other statutory bodies to convey to their staff and service users the important reports of the country and speeches of state leaders, such as the report to the 20th National Congress of the Communist Party of China or the address made by President XI Jinping on 1 July.*

Note: Hon TANG Ka-piu’s amendment is marked in *bold and italic type*.

3. Motion as amended by Hon YIM Kong

That this Council urges the Government to promote public understanding of the country on all fronts, including the country's fundamental systems and constitutional system, the history and mission of the Communist Party of China, as well as the country's strategies to cope with global changes of a magnitude not seen in a century and to realize the great rejuvenation of the Chinese nation; at the same time, the Government should strengthen the education and promotion of Chinese history (*the major content includes the history of Britain starting the Opium War to forcibly occupy Hong Kong, the history of the War of Resistance in Hong Kong, China, as well as the history of Hong Kong's participation in the reform and opening up of the Mainland and the country's great achievements since its reform and opening up*) and Chinese culture *with patriotism education as its core as well as national security with the Constitution and the Basic Law as its basis*, so as to enable the public to have a comprehensive understanding of the good stories of China and Hong Kong, China, thereby enhancing the sense of identity among the public towards the country and Hong Kong, *in particular enhancing young people's sense of pride towards the achievements of the country's development and their confidence in the history and culture of the nation, in order to better promote the return of people's heart to the Motherland.*

Note: Hon YIM Kong's amendment is marked in *bold and italic type*.
