3. At the House Committee meeting on 25 February 2022, the House Committee formed a subcommittee to study in detail items (1) to (4), which are

- 5. In respect of items (8) to (13), the House Committee considered it not necessary to form any subcommittee to study these six items of subsidiary legislation.
