Report No. 14/2022 of the House Committee on Consideration of Subsidiary Legislation and Other Instruments

Purpose

This report gives the outcome of the consideration of the House Committee on subsidiary legislation the period for amendment of which will expire at the Council meeting of 13 July 2022.

3. The House Committee formed two subcommittees to study item (1) and item (2) respectively in detail at its meeting on 27 May 2022. The two Subcommittees provided Members with written reports vide LC Paper Nos. CB(1)399/2022 and CB(2)498/2022 on 23 June 2022 respectively, and reported their deliberations at the House Committee meeting on 8 July 2022.

4. In respect of items (3) to (17), the House Committee considered it not necessary to form any subcommittee to study these 15 items of subsidiary legislation.

Notes: (a) The House Committee formed three subcommittees to study the following three items of subsidiary legislation at its meeting on 17 June 2022. (b) At the House Committee meeting on 17 June 2022, the House Committee agreed that the following two items of subsidiary legislation should be studied in detail by the Subcommittee on Subsidiary Legislation Relating to the Prevention and Control of Disease which had been formed at the House Committee meeting on 25 February 2022.
