Explanatory Note

Under section 14H of the Medical Registration Ordinance (Cap. 161) (***Ordinance***), on receiving a recommendation made by the Special Registration Committee on the medical qualifications to be recognized for the purpose of granting a special registration under section 14C of the Ordinance, the Registrar of Medical Practitioners must recognize those medical qualifications by amending Schedule 1A to the Ordinance (***Schedule 1A***).

2. This Notice amends Schedule 1A to recognize the medical qualifications recommended by the Special Registration Committee.
