**Council meeting of 22 March 2023**

**Amendments to Dr Hon CHOW Man-kong's motion on  
"Promoting the integration of Hong Kong people and businesses  
into the overall development of the country"**

Further to the email (LC Paper No. CB(3)159/2023) issued on 9 March 2023, the President has given permission for three Members (Dr Hon Johnny NG, Dr Hon Kennedy WONG and Hon YIM Kong) to move amendments to Dr Hon CHOW Man-kong's motion, and has directed that the amendments be printed in the terms in which they were handed in on the Agenda of the Council.

2. The President will order a joint debate on the above motion and the amendments. I set out below the relevant proceedings in which the President will:

- (a) call upon the motion mover to speak and move the motion;
- (b) propose the question on the motion;
- (c) call upon the Members who wish to move amendments to the motion to speak in the following order, but no amendment is to be moved at this stage:
  - (i) Dr Hon Johnny NG;
  - (ii) Hon YIM Kong; and
  - (iii) Dr Hon Kennedy WONG;
- (d) call upon the public officer(s) to speak;

- (e) invite other Members to speak;
- (f) call upon the motion mover to speak on the amendments;
- (g) call upon the public officer(s) to speak again;
- (h) deal with the amendments in the order set out in paragraph (c) above, i.e. first invite the mover of the first amendment to move the amendment and forthwith propose and put to vote the question on the amendment, and thereafter proceed to deal with the remaining amendment(s); and
- (i) after all amendments have been dealt with, call upon the motion mover to reply, and then put to vote the question on the motion, or the motion as amended, as the case may be.

3. The terms of the original motion and the marked-up version of the amendments (LC Paper No. CB(3)189/2023(01)) are attached for Members' easy reference. The amendments are also accessible via the hyperlink below: <https://www.legco.gov.hk/yr2023/english/counmtg/motion/cm20230322m-cmk.htm>.

4. Members are reminded that in accordance with Appendix IIIA to the House Rules, the **maximum duration of this joint debate (including voting) is four hours**. The motion mover will have a total of 10 minutes to make introductory speech and reply (paragraph 2(a) and (i) above refers), and another five minutes to speak on the amendment(s) (paragraph 2(f) above refers). The mover(s) of the amendment(s) and other Members may each speak once up to a maximum of five minutes.

**Motion debate on  
“Promoting the integration of Hong Kong people and businesses  
into the overall development of the country”**

**1. Dr Hon CHOW Man-kong’s original motion**

That it is mentioned in the report to the 20th National Congress of the Communist Party of China that the country will support Hong Kong and Macao in better integrating themselves into its overall development and playing a greater role in realizing the great rejuvenation of the Chinese nation; in order to further accelerate the pace of integration of Hong Kong, especially Hong Kong people and businesses, into the overall development of the country, this Council urges the SAR Government to improve the functions and services of the relevant policy bureaux and public organizations in a bid to expeditiously enhance the policy measures that support Hong Kong people and businesses as well as their related organizations, and draw up specific key performance indicators for medium- and long-term initiatives and a concrete blueprint for the development of ‘intergovernmental relations’, with a view to strengthening impetus for growth and promoting Hong Kong’s long-term prosperity and stability.

**2. Motion as amended by Dr Hon Johnny NG**

That *President XI Jinping has stressed the need to enhance the coverage of domestic circulation, promote the orderly relocation of key industries within and outside the country, and strengthen China’s discourse power in international circulation, thereby leading and guiding Hong Kong to seize the enormous opportunities brought about by the national development; at the same time*, it is mentioned in the report to the 20th National Congress of the Communist Party of China that the country will support Hong Kong and Macao in better integrating themselves into its overall development and playing a greater role in realizing the great rejuvenation of the Chinese nation; in order to further accelerate the pace of integration of Hong Kong, especially Hong Kong people and businesses, into the overall development of the country, this Council urges the SAR Government to improve the functions and services of the relevant policy bureaux and public organizations in a bid to expeditiously enhance the policy measures that support Hong Kong people and businesses as well as their related organizations, ~~and~~ draw up specific key performance indicators for medium- and long-term initiatives and a concrete blueprint for the development of ‘intergovernmental relations’, *and strengthen the support for Hong Kong businesses by promoting sales of ‘Brand Hong Kong’ in the Mainland*, with a

view to strengthening impetus for growth and *enabling Hong Kong to play a better role as a ‘participant’ in domestic circulation and a ‘facilitator’ of international circulation, thereby* promoting Hong Kong’s long-term prosperity and stability.

### **3. Motion as amended by Hon YIM Kong**

That it is mentioned in the report to the 20th National Congress of the Communist Party of China that the country will support Hong Kong and Macao in better integrating themselves into its overall development and playing a greater role in realizing the great rejuvenation of the Chinese nation; in order to further accelerate the pace of integration of Hong Kong, especially Hong Kong people and businesses, into the overall development of the country, this Council urges the SAR Government to improve the functions and services of the relevant policy bureaux and public organizations *and make use of the new Steering Group on Integration into National Development* in a bid to *review and revise the implementation mechanism for aligning with national development strategies*, expeditiously enhance the policy measures that support Hong Kong people and businesses as well as their related organizations, *foster the awareness of proactively serving the country’s development among Hong Kong people and businesses*, and draw up specific key performance indicators for medium- and long-term initiatives and a concrete blueprint for the development of ‘intergovernmental relations’, with a view to strengthening impetus for growth and promoting Hong Kong’s long-term prosperity and stability.

That it is mentioned in the report to the 20th National Congress of the Communist Party of China that the country will support Hong Kong and Macao in better integrating themselves into its overall development and playing a greater role in realizing the great rejuvenation of the Chinese nation; in order to further accelerate the pace of integration of Hong Kong, especially Hong Kong people and businesses, into the overall development of the country, this Council urges the SAR Government to improve the functions and services of the relevant policy bureaux and public organizations in a bid to expeditiously enhance the policy measures that support Hong Kong people and businesses as well as their related organizations, ~~and~~ draw up specific key performance indicators for medium- and

long-term initiatives and a concrete blueprint for the development of 'intergovernmental relations', ~~with a view to strengthening~~ ***and strongly support Hong Kong's patriotic societies and patriots in various positions to play a role in the integration of Hong Kong people and businesses into the overall development of the country, so as to strengthen*** impetus for growth and ~~promoting~~ ***promote*** Hong Kong's long-term prosperity and stability ***through cooperation between the Government and the community.***
