## Housing (Traffic Contraventions) (Fixed Penalty) (Amendment) Bylaw 2023

(Made by the Housing Authority under section 30 of the Housing Ordinance (Cap. 283) subject to the approval of the Legislative Council)

### 1. Commencement

This Bylaw comes into operation on 1 October 2023.
