The Administration will brief members on the proposal to convert a supernumerary D1 post of Chief Building Surveyor/Chief Structural Engineer (which will lapse on 15 July 2024) into a permanent post to provide continued leadership in overseeing the enforcement strategy and measures against unauthorized building works in New Territories Exempted Houses.

2. Adoption of advanced construction technologies

The Administration will brief the Panel on the measures to drive the adoption of advanced construction technologies (such as Building Information Modelling and Modular Integrated Construction) by the construction industry and relevant measures to address the manpower needs of the construction industry.

April 2024 (Note)

Note: At the Panel meeting on 25 January 2022, Hon LAU Kwok-fan and Hon Andrew LAM suggested that the Administration should brief the Panel on its measures to drive the adoption of advanced construction technologies (such as Building Information Modelling and Modular Integrated Construction) by the construction industry. As

agreed at the work plan meeting on 13 February 2023 and suggested by Hon TANG Ka-piu at the Panel meeting on 16 January 2024, the briefing by the Administration should also cover the strategy for increasing and ensuring the sustainable supply of manpower for the construction industry.

3. Legislative amendment proposals for the Protection of the Harbour Ordinance (Cap. 531)

The Administration will brief members on the views collected in 2023 in relation to the amendment of the Protection of the Harbour Ordinance (Cap. 531) and seek members' views on the proposed legislative amendments.

4. Progress of work by the Sustainable Lantau Office

The Administration will brief members on the proposals for South Lantau Eco-recreation Corridor and the progress of other work of the Sustainable Lantau Office of the Civil Engineering and Development Department.

May 2024

5. Development proposal of New Territories North New Town (including Lo Wu/Man Kam To)

The Administration will brief members on the initial development proposal of New Territories North New Town (including Lo Wu/Man Kam To), including the major planning concepts and development themes.

May 2024

6. Annual report on implementation progress of heritage conservation initiatives

The Administration will update members on the progress of various heritage conservation initiatives since July 2023.

June 2024 *(Note)*

Note: At the Panel meeting on 16 January 2024, Hon YIU Pak-leung suggested that the Development

Bureau and other relevant policy bureaux should jointly brief the Panel on the work of promoting characteristic local tourism by making better use of historic buildings through collaboration across bureaux. The Administration has advised that it will brief members on the ways of making use of historic buildings for tourism purposes in the context of the Panel's discussion of the progress of heritage conservation initiatives in June 2024.

7. Work of the Urban Renewal Authority

The Administration will brief members on the progress of the work of the Urban Renewal Authority ("URA") in 2023-2024 and its plan for the next financial year.

June 2024 *(Note)*

Note: At the Panel meeting on 16 January 2024, Hon CHAN Han-pan suggested that the Administration should brief the Panel on how the Urban Renewal Strategy would be implemented to enhance the efficiency of urban renewal. The Administration has advised that efforts to enhance urban renewal have been and will continue to be made on an on-going basis, citing the introduction of the Land (Compulsory Sale for Redevelopment) (Amendment) Bill 2023 as a recent example. The Administration will brief members on the latest progress in the context of the Panel's discussion of URA's work of the year in June 2024.

8. Maintenance and repair of lifts and escalators

The Administration will brief the Panel on the measures taken to enhance the proper maintenance and repair of lifts and escalators.

June 2024 *(Note)*

Note: At the Panel meeting on 16 January 2024, Hon TANG Ka-piu suggested that the Administration should brief the Panel on the aforesaid measures.

9. Streamlining of development-related administrative procedures within the Government

The Administration will brief the Panel on the progress made by the Government in streamlining development-related administrative procedures, which includes the relevant approval procedures and standards, the self-certification and independent checking arrangements, as well as the work of the Development Projects Facilitation Office under the Development Bureau.

Note: At the Panel meeting on 16 January 2024, Hon LAU Kwok-fan and the Deputy Chairman (Hon Andrew LAM) suggested that the Administration should brief the Panel on the progress of streamlining the development-related administrative processes within the Government, as well as the functions of the Development Projects Facilitation Office under the Development Bureau and the arrangements for self-certification and independent checking.

10. Funding applications in relation to the updating and streamlining of the compulsory sale regime

The Administration will brief members on the following two funding applications in relation to the updating and streamlining of the compulsory sale regime:

(a) the proposed creation of two permanent directorate posts for the Lands Tribunal of the Judiciary, including one Judge of the District Court at Judicial Service Pay Scale ("JSPS") Point 13 and one Member at JSPS Point 12, with immediate effect upon approval by the Finance Committee to cope with the anticipated increase in workload of the Lands Tribunal after the passage of the Land (Compulsory Sale for Redevelopment) (Amendment) Bill 2023 which was introduced into the Legislative Council on 19 December 2023; and

(b) the proposed launch of a dedicated loan scheme with government guarantee to provide bridging loan for eligible minority owners having genuine liquidity problem to support their upfront payment of professional service fees to handle compulsory sale litigation cases.

Note: The Administration has suggested extending a special invitation to members of the Panel on Administration of Justice and Legal Services to join the discussion of this item.

11. Supply of construction materials

At the Panel meeting on 16 January 2024, Dr Hon CHOW Man-kong suggested that the Administration should brief the Panel on the measures to ensure the supply of construction materials to cope with the demand of the construction industry.

12. Improving the infrastructure in remote villages

At the Panel meeting on 25 January 2022, Ms Alice MAK. then Member, suggested Administration should brief the Panel on the provision supply in remote fresh water Hon CHAN Yuet-ming raised in her letter to the then Chairman dated 30 March 2022 (LC Paper No. CB(1)186/2022(01)) and reiterated at the Panel meeting on 16 January 2024 her suggestion of broadening the scope of discussion under this item to cover the provision of other infrastructural facilities (e.g. mobile network service, internet access via optic fibre/broadband, sewerage system and prevention system) for remote villages. At the Panel meeting on 16 January 2024, Hon TANG Ka-piu further suggested that the Administration should brief the Panel on the overall progress of providing water and electricity supply facilities in remote villages.

Q2/Q3 2024 (Note)

Note: The Administration has advised that an update on provision of water supply facilities for remote villages (e.g. Tung Ping Chau and Po Toi Island) was covered in the paper provided for the discussion of supply of Dongjiang water on 13 December 2023 (LC Paper No. CB(1)1110/2023(03)). As the infrastructure facilities mentioned by members span across bureaux and departments, the Development Bureau will work with relevant teams with a view to updating the Panel on the supply of water, flood prevention and other infrastructure facilities for remote villages in Q2 or Q3 of 2024.

13. Northern Metropolis—Development proposals of Ngau Tam Mei and Ma Tso Lung

The Administration will brief members on the initial development proposals of two New Development Areas at Ngau Tam Mei and Ma Tso Lung in the Northern Metropolis, including the major planning concepts and development themes.

14. Study on the Artificial Islands in the Central Waters

At the Panel meeting on 16 January 2024, Hon Tony TSE suggested that the Administration should update the Panel on the latest progress of the Study on the Artificial Islands in the Central Waters after the interim report made to the Panel in December 2022.

15. Report published by the Law Reform Commission on Adverse Possession

The Administration has considered a report released by the Law Reform Commission ("LRC") on the topic of Adverse Possession on 20 October 2014. The Administration agrees with LRC's recommendation that the existing provisions on adverse possession should be retained under the current deeds registration system, and will continue to keep in view the development of the law on adverse Q3/Q4 2024

possession and related aspects for necessary review as and when necessary. The Development Bureau also explained its position on this matter in an oral reply to a question at the Council meeting of 1 September 2021. The Administration will brief the Panel when there are further developments.

A letter from the Clerk to the Panel on Administration of Justice and Legal Services issued to the Secretary for Development on matters relating to the LRC Report on Adverse Possession in the 2022 session and the Development Bureau's response (LC Paper Nos. CB(4)862/2022(01) and (02)) (English version only) were circulated to members of the Panel on Development on 5 October 2022.

Note: The Administration has advised that members were briefed on the legislative proposals for implementing title registration for newly granted land at the Panel meeting on 19 December 2022. Panel was informed that the Administration would actively consider the feasibility of dis-applying the adverse possession law to new land registered under the proposed title registration system, and would handle the matters relating to the existing adverse possession law in tandem with the study on the full implementation of the title registration system on The Administration has indicated that existing land. it targets to put forward options on implementing the conversion of existing land to the title registration system for discussion with stakeholders Legislative Council Members after the passage of legislation in relation to the proposed title registration system for newly granted land. It aims at introducing the Land Titles (Amendment) Bill into the Legislative Council in the second half of 2024 for implementing title registration on newly granted land. An information paper prepared by the Administration on "Implementation of the Recommendations Made by the Law Reform Commission" (LC Paper No. AS6/2023) was circulated to all Members on

30 August 2023. The latest position of matters relating to the LRC Report on Adverse Possession is given in the Annex to the information paper (Item 59).

16. Legislative amendments to the Waterworks Ordinance (Cap. 102)

Subsequent to the public consultation on the legislative amendment proposals of the Waterworks Ordinance (Cap. 102) completed in February 2021, the Administration is preparing for the drafting of the Waterworks (Amendment) Bill 2024 and will brief the Panel on the legislative amendment proposal to strengthen the regulation of construction and maintenance of inside service and further enhance drinking water safety and water use efficiency.

17. Proposals for promoting elderly friendly building design

The Administration will brief members on the proposals for promoting elderly friendly building design and to incorporate more comprehensively the concepts of universal design and accessibility into the Buildings Department's building design manual and relevant regulations and guidelines.

18. Proposals to enhance enforcement under the Buildings Ordinance (Cap. 123) and regulation of contractors

The Administration will consult members on the proposals to amend the Buildings Ordinance (Cap. 123) with a view to stepping up enforcement against non-compliance of statutory orders/notices and strengthening the regulation of contractors.

19. Near shore reclamation proposals

Dr Stephen WONG, a then Member, wrote to the then Chairman on 31 January 2022 (LC Paper No. CB(1)41/2022(01)) expressing views on the near shore reclamation proposals at four sites (namely Lung Kwu Tan, Ma Liu Shui, Siu Ho Wan and Sunny Bay) and proposed that the Panel should discuss the progress of these reclamation proposals.

Being arranged on project basis (Note)

Note: The Administration has advised that the progress of near shore reclamation proposals at the four sites was briefly reported by the Secretary for Development at the Panel meeting on 10 February 2022. Individual items relating to these proposals will be put to the Panel for discussion before further submission to the Public Works Subcommittee. With the Panel's support to commence study on reclamation of Lung Kwu Tan in Q1 2023 and after obtaining the Finance Committee's approval, the consultancy study has been awarded in December 2023 for commencement of work as soon as possible.

20. Redevelopment of three squatter areas in Kowloon East

At the Panel meeting on 17 January 2023, Hon TANG Ka-piu suggested that the Administration should brief the Panel on the progress of the redevelopment of the three squatter areas in Kowloon East (i.e. Cha Kwo Ling Village, Ngau Chi Wan Village and Chuk Yuen United Village).

Being arranged on project basis (Note)

Note: The Administration briefed members on the funding proposal for the site formation and infrastructure works for the public housing development at Cha Kwo Ling Village at the Panel meeting on 28 March 2023. The Panel supported the funding proposal. The Finance Committee subsequently approved the funding proposal on 2 June 2023. The construction works commenced in July

2023. In addition, the Administration has advised that it will brief members on the site formation and infrastructure works for the public housing development at Ngau Chi Wan Village, Wong Tai Sin in April 2024.

21. Development of the Northern Metropolis

At the Panel meeting on 16 January 2024, Dr Hon Wendy HONG requested the Administration to update the Panel on the land use proposal for San Tin Technopole in the light of the public engagement exercise conducted in 2023.

An information paper on the amendments announced earlier will be provided for the Panel

22. Future use of existing community isolation facilities

At the meeting of the Panel on Security ("SE Panel") on 17 January 2023, Hon TANG Ka-piu suggested discussing issues relating to the future use of existing community isolation facilities following the subsiding of the Coronavirus Disease 2019 epidemic. The Clerk to SE Panel subsequently wrote to refer the above-mentioned matter to the Panel on Development for consideration and follow-up.

To be decided (Note)

Note: The Administration has advised that the Chief Executive announced on 31 January 2023 that Deputy Financial Secretary would coordinating an assessment on the future use of the facilities, taking into account the potential changes in the epidemic situation, the return to normalcy and social needs. Upon reviewing the existing community isolation facilities and ensuring the retention of a certain amount of facilities, the relevant land will be released in phases and units of the isolation facilities will be reused. So far, the Administration has announced alternative uses of such facilities in Tsing Yi, San Tin, Tam Mei and the Loop.

23. Review of Hong Kong Planning Standards and Guidelines

At the Panel meeting on 16 January 2024, the Chairman (Ir Dr Hon LO Wai-kwok) suggested that the Administration should review and update the Hong Kong Planning Standards and Guidelines ("HKPSG") and brief the Panel on the matters concerned.

To be decided (Note)

Note: The Administration has advised that topical reviews of specific standards and guidelines in **HKPSG** are conducted individual bv bureaux/departments ("B/Ds") as and when necessary, taking into account the concerned B/Ds' latest policies and development requirements in the relevant areas. For instance, the then Transport and Housing Bureau/Transport Department briefed the Panel on Transport at its meeting held on 20 August 2021 on a range of measures to increase the provision of parking spaces, and HKPSG was subsequently updated to reflect the relevant latest standards. Since HKPSG is a collection of planning standards and guidelines covering a wide range of facilities and land uses that fall within the purview of different B/Ds, the Development Bureau will continue to remind relevant B/Ds to review the standards under their purview periodically, in consultation with relevant stakeholders and relevant Panels.

24. Review of squatter control policy

At the Panel meeting on 16 January 2024, Hon CHAN Han-pan suggested that the Administration should review the squatter control policy and brief the Panel on the matters concerned.
