Explanatory Note

This Notice amends the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19Y(3)) Notice (Cap. 485 sub. leg. K) to appoint a date for—

- (a) each of the 16 specified constituent funds of the AMTD MPF Scheme;
- (b) each of the 13 specified constituent funds of the BCT Strategic MPF Scheme; and
- (c) each of the 13 specified constituent funds of the Manulife RetireChoice (MPF) Scheme.

2. The date appointed is 3 October 2025. The date is appointed for the purposes of section 19Y(3) of the Mandatory Provident Fund Schemes Ordinance (Cap. 485).
