Explanatory Note

This Notice amends the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19Z(4)) Notice (Cap. 485 sub. leg. L) to appoint a date for—

- (a) each of the 15 specified constituent funds of the AMTD MPF Scheme;
- (b) each of the 12 specified constituent funds of the BCT Strategic MPF Scheme; and
- (c) each of the 12 specified constituent funds of the Manulife RetireChoice (MPF) Scheme.

2. The date appointed is 3 October 2025. The date is appointed for the purposes of section 19Z(4) of the Mandatory Provident Fund Schemes Ordinance (Cap. 485).
