**Explanatory Note**

This Notice amends the Mandatory Provident Fund Schemes (Appointment of Dates for Purposes of Section 19Y(3)) Notice (Cap. 485 sub. leg. K) to appoint—

- (a) a date for each of the 27 specified constituent funds of the BCT (MPF) Pro Choice; and
  - (b) a date for each of the 20 specified constituent funds of the AIA MPF - Prime Value Choice.
2. The dates are appointed for the purposes of section 19Y(3) of the Mandatory Provident Fund Schemes Ordinance (Cap. 485).
3. The date appointed for each of the specified constituent funds of the BCT (MPF) Pro Choice is 1 November 2025 and the date appointed for each of the specified constituent funds of the AIA MPF - Prime Value Choice is 3 December 2025.
