# Dangerous Drugs Ordinance (Amendment of Second and Fourth Schedules) Order 2025

## **Explanatory Note**

This Order amends the Second Schedule to the Dangerous Drugs Ordinance (Cap. 134) (*principal Ordinance*) to—

- (a) update the names of 2 institutions in the list of prescribed hospitals and institutions; and
- (b) add 1 hospital and 2 institutions to the list of prescribed hospitals and institutions.
- 2. The Order also amends the Fourth Schedule to the principal Ordinance to—
  - (a) delete 2 bodies or organizations from the list of reporting agencies;
  - (b) update the name of 1 organization in the list of reporting agencies; and
  - (c) add 1 organization to the list of reporting agencies.
