**Immigration (Amendment) (No. 2) Regulation 2025**

### **Explanatory Note**

This Regulation amends Part 2 of Schedule 2 to the Immigration Regulations (Cap. 115 sub. leg. A) to increase certain fees set out in that Part. Those fees include fees payable for the issue or renewal of documents issued by or on behalf of the Director of Immigration and for visas and other matters under the Immigration Ordinance (Cap. 115).
