Order 2026**

(Made by the Director of Leisure and Cultural Services under  
section 106 of the Public Health and Municipal Services  
Ordinance (Cap. 132))

**1. Commencement**

This Order comes into operation on 10 July 2026.

**Explanatory Note**

This Order sets aside 1 place for use as a public pleasure ground.

2. The Order also provides that 2 places cease to be set aside for use as public pleasure grounds.
3. In addition, the Order amends the Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) to—
  - (a) add the place mentioned in paragraph 1;
  - (b) remove the 2 places mentioned in paragraph 2; and
  - (c) rename 2 existing public pleasure grounds.
