The Democratic Party's proposed amendments to the District Councils Bill to strengthen the functions of the secretary of a District Council

The development of representative government in Hong Kong started in the 1980s. The next term of the District Boards (to be renamed District Councils) will straddle their 20th anniversary so there is every reason for the new DCs to be fully-elected. Besides, an independent secretariat should be set up for each DC to assist the DC to discharge its functions more effectively.

The Democratic Party (DP) proposes that at this stage, each DC may appoint its own secretary. Apart from performing the duties assigned by the DC, the secretary should also be responsible for handling matters relating to members' acceptance of office, membership, members' resignation and vacancy in membership. Moreover, the secretary should preside at the meeting for the purpose of electing the chairman of the DC and be delivered a copy of the court's determination on election petitions. These duties are similar to those of the Clerk to the Legislative Council so DP's amendments are proposed with reference to the Legislative Council Ordinance.

It is necessary to set up an independent Commission for DCs, similar to the Legislative Council Commission, in the long run. The Commission will be responsible for providing administrative support and services for DCs through their respective secretariats and supervising the operation of the secretariats.
