I. Meeting with the Administration

(LC Paper No. CB(2)586/99-00(01))

The Chairman referred to the above paper provided by the Secretary General of the Hong Kong Arts Development Council (ADC) in response to the points raised by members at the last meeting and asked representatives of the Administration whether they had anything to add to the paper. Principal Assistant Secretary for Home Affairs (Task Force) (PASHA(TF)) said that as the response from the ADC was quite detailed, he only wished to inform members that the ADC's new term had started and the Administration hoped that the expanded membership could be implemented early to enhance community participation.

2. As members had no further questions, the meeting proceeded to examine the Bill clause by clause.

II. Clause-by-clause examination of the Bill

- 3. <u>Members</u> had no comments on clause 1. As regards clause 2, <u>members</u> noted that with the passage of the Provision of Municipal Services (Reorganization) Bill, section 3 (3) (b) and (c) of the Hong Kong Arts Development Council Ordinance (Cap. 472) providing for two representatives from the former Provisional Municipal Councils had been deleted.
- 4. In reply to the Chairman's question on the effective date of the expanded membership, <u>PASHA(TF)</u> said that the Administration would implement the proposals as soon as possible.

III. Way forward

5. The Chairman said that since the Bills Committee had completed scrutiny of the

Bill and members had no further questions, he would make a verbal report to the House Committee the following day to release a slot for activating the next Bills Committee on the waiting list. A written report would be made to the House Committee on 14 January 2000 to recommend resumption of the Second Reading debate on the Bill on 26 January 2000.
