ADAPTATION OF LAWS (NO. 30) BILL 1999

INTRODUCTION

At the meeting of the Executive Council on 6 July 1999, the Council ADVISED and the Chief Executive ORDERED that the Adaptation of Laws (No. 30) Bill 1999, at the Annex, should be introduced into the Legislative Council.

BACKGROUND AND ARGUMENT

2. There are provisions in the Ordinances which are inconsistent with the Basic Law or with Hong Kong's status as a Special Administrative Region of the People's Republic of China. The Adaptation of Laws (No. 30) Bill 1999 seeks to adapt these provisions with a view to bringing them into conformity with the Basic Law and Hong Kong's present status.

THE BILL

- 3. Most of the proposed amendments are terminological changes, e.g. references to "the Colony" and "Governor" are replaced by "Hong Kong" and "Chief Executive" respectively.
- 4. The references to "Her Majesty the Queen, Her Heirs or Successors" in the saving provisions in the Bill are replaced by "the Central Authorities or the Government of the Hong Kong Special Administrative Region under the Basic Law and other laws". This amendment is proposed with reference to item 10 of Annex 3 of the "Decision of the Standing Committee of the National People's Congress on Treatment of Laws Previously in Force in Hong Kong in accordance with Article 160 of the Basic Law of the Hong Kong Special Administrative Region", which states that -

"Any reference in any provision to "nothing in this Ordinance shall affect or be deemed to affect the rights of Her Majesty the Queen, Her Heirs or Successors" shall be construed as a reference to "nothing in this Ordinance shall affect or be deemed to affect the rights of the Central People's Government or the Government of the Hong Kong Special Administrative Region under the Basic law or other laws"."

5. Where the expression "Crown" or other similar expression is used in provisions which deal with the use and management of land in Hong Kong, it will be adapted to "Government". This amendment is based on the principle of land management laid down in Article 7 of the Basic Law. Article 7 sets out that the SAR Government shall be responsible for the management, use and development of land. Examples of these adaptations are the amendment of "Crown" and "Her Majesty, Her Heirs, Successors or Assigns" to "Government" in section 6(1) and (2) respectively in the Church of England Trust Ordinance (Cap. 1014).

COMMENCEMENT

6. The Bill provides that the adaptations when passed into law, and subject to Article 12 of the Hong Kong Bill of Rights shall take effect retrospectively, as from the date of the establishment of the Hong Kong Special Administrative Region.

LEGISLATIVE TIMETABLE

HUMAN RIGHTS IMPLICATIONS

8. The Department of Justice advises that the proposed Bill is consistent with the human rights provisions of the Basic Law.

BINDING EFFECT

9. The amendments in the Bill do not affect the current binding effect of the existing provisions of various Ordinances covered by the Bill.

FINANCIAL AND STAFFING IMPLICATIONS

10. There are no financial or staffing implications arising from the Bill.

PUBLIC CONSULTATION

11. Since the amendments are essentially straightforward adaptations, consultation with the public is not considered necessary. The private bodies concerned have been consulted. They have not raised any objection to the proposed amendments.

PUBLICITY

12. A press release will be issued on 7 July 1999 and the Bill will be gazetted on 9 July 1999.

A BILL

To

Adapt certain Ordinances to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

Enacted by the Legislative Council.

1. Short title

This Ordinance may be cited as the Adaptation of Laws (No. 30) Ordinance 1999.

2. Commencement

- (1) This Ordinance shall be deemed to have come into operation on 1 July 1997.
- (2) Subsection (1) shall be subject to Article 12 of the Hong Kong Bill of Rights set out in Part II of the Hong Kong Bill of Rights Ordinance (Cap. 383).

3. Amendment of Ordinances

SCHEDULE 24 [s. 3] THE ORTHODOX METROPOLITANATE OF HONG KONG AND SOUTH EAST ASIA ORDINANCE

1. Section 13 of The Orthodox Metropolitanate of Hong Kong and South East Asia Ordinance (Cap. 1163) is amended by repealing "Her Majesty the Queen, Her Heirs or Successors" and substituting "the Central Authorities or the Government of the Hong Kong Special Administrative Region under the Basic Law and other laws".

Explanatory Memorandum

The purpose of this Bill is to adapt certain Ordinances to bring them into conformity with the Basic Law and with Hong Kong's status as a Special Administrative Region of the People's Republic of China (clause 3, Schedules 1 to 24).
