ADAPTATION OF LAWS (NO.14) BILL 1998

INTRODUCTION

At the meeting of the Executive Council on 8 December 1998, the Council ADVISED and the Chief Executive ORDERED that the Adaptation of Laws (No.14) Bill 1998 should be introduced into the Legislative Council to effect necessary adaptations to 24 Ordinances relating to the incorporation of various religious organisations.

BACKGROUND AND ARGUMENT

2. There are provisions in the aforementioned Ordinances which are inconsistent with the Basic Law or with Hong Kong's status as a Special Administrative Region of the People's Republic of China. The Adaptation of Laws (No.14) Bill seeks to adapt these provisions with a view to bringing them into conformity with the Basic Law and Hong Kong's present status.

THE BILL

3. Most of the proposed amendments are terminological changes. For example, references to "立法局" and "the Colony" are replaced by "立法會" and "Hong Kong" respectively. Similarly, a reference to "the Governor" will be replaced by "the Chief Executive". The provisions saving the rights of "Her Majesty the Queen, Her Heirs or Successors" will be amended to saving the rights of "the Central People's Government or the Government of the Hong Kong Special Administrative Region" based on item 10 of Annex 3 of the Decision of the Standing Committee of the National People's Congress on Treatment of the Laws Previously in Force in Hong Kong in accordance with Article 160

of the Basic Law of the Hong Kong Special Administrative Region of the People's Republic of China.

COMMENCEMENT

4. The Bill provides that, subject to Article 12 of the Hong Kong Bill of Rights, the adaptations when passed into law shall take effect retrospectively, as from the date of the establishment of the Hong Kong Special Administrative Region.

LEGISLATIVE TIMETABLE

5. The proposed legislative timetable is as follow:

HUMAN RIGHTS IMPLICATION

6. The Department of Justice advises that the proposed Bill is consistent with the human rights provisions of the Basic Law.

BINDING EFFECT

7. The amendments in the Bill do not affect the current binding effect of the

existing provisions of various Ordinances covered by the Bill.

FINANCIAL AND STAFFING IMPLICATIONS

8. There are no financial or staffing implications arising from the Bill.

PUBLIC CONSULTATION

9. Since the amendments are essentially straightforward adaptations,

consultation with the public is not considered necessary. However, the relevant church

bodies have been consulted and they have no objection to the proposed amendments.

PUBLICITY

10. A press release will be issued on 16 December 1998. The Bill will be

gazetted on 18 December 1998.

A BILL

To

Adapt certain Ordinances to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

Enacted by the Legislative Council.

1. Short title

This Ordinance may be cited as the Adaptation of Laws (Subject No. 14) Ordinance 1998.

2. Commencement

- (1) This Ordinance shall be deemed to have come into operation on 1 July 1997.
- (2) Subsection (1) shall be subject to Article 12 of the Hong Kong Bill of Rights set out in Part II of the Hong Kong Bill of Rights Ordinance (Cap. 383).

3. Amendment of Ordinances

CONGREGATION OF OUR LADY OF CHARITY OF THE GOOD SHEPHERD OF ANGERS AT HONG KONG INCORPORATION ORDINANCE

- 1. Section 2 of the Congregation of Our Lady of Charity of the Good Shepherd of Angers at Hong Kong Incorporation Ordinance (Cap. 1084) is amended by repealing "the Colony" and substituting "Hong Kong".
- 2. Section 6 is amended by repealing "Governor" wherever it appears and substituting "Chief Executive".
- 3. Section 7 is amended by repealing "Her Majesty the Queen, Her Heirs or Successors" and substituting "the Central People's Government or the Government of the Hong Kong Special Administrative Region under the Basic Law or other laws".

Explanatory Memorandum

The purpose of this Bill is to adapt certain Ordinances and their subsidiary legislation to bring them into conformity with the Basic Law and with Hong Kong's status as a Special Administrative Region of the People's Republic of China (clause 3, Schedules 1 to 24).
