ADAPTATION OF LAWS BILL 1999

INTRODUCTION

At the meeting of the Executive Council on 5th January 1999, the Council ADVISED and the Chief Executive ORDERED that the

Adaptation of Laws Bill 1999, at Annex, should be introduced into the Legislative Council to effect necessary adaptations to 17 Ordinances on matters related to private bodies.

BACKGROUND AND ARGUMENT

2. The Bill covers 17 Ordinances which are related to private bodies. These ordinances contain references which are inconsistent with the Basic Law or with Hong Kong's status as a Special Administrative Region of the People's Republic of China. Adaptation is required to remove such inconsistencies.

THE BILL

- 3. Most of the proposed amendments are merely terminological changes. For instance, references to the "Colony" and the "Governor" are replaced by "Hong Kong" and the "Chief Executive" respectively. In accordance with section 21 of Schedule 8 to the Interpretation and General Clauses Ordinance, provisions saving the rights of "Her Majesty the Queen, Her Heirs or Successors" are adapted as saving the rights of "the Central People's Government or the Government of the Hong Kong Special Administrative Region under the Basic Law or other laws".
- 4. References to the "Crown" in the following provisions relate to land, and are replaced by the "Government" -
 - (a) section 5(a) of the Society of Boys' Centres Incorporation Ordinance;
 - (b) section 4(3) of The Helena May Incorporation Ordinance; and
 - (c) section 6(1) of the Hong Kong Tuberculosis, Chest and Heart Diseases Association Incorporation Ordinance.

Article 7 of the Basic Law states that the lands within the Hong Kong Special Administrative Region shall be State property, and that the Government of the Hong Kong Special Administrative Region shall be responsible for the management, use, development, lease and grant of the lands. As the above provisions relate to the grant or reversion of the lands (as opposed to their title), the references to the "Crown" in the provisions are replaced by the "Government" accordingly.

COMMENCEMENT

5. The Bill provides that, subject to Article 12 of the Hong Kong Bill of Rights, the adaptations, when passed into law, shall take effect retrospectively, as from the date of the establishment of the Hong Kong Special Administrative Region.

LEGISLATIVE TIMETABLE

6. The legislative timetable approved by the Chief Executive in Council is as follows -

HUMAN RIGHTS IMPLICATIONS

7. The Department of Justice advises that the Bill is consistent with the human rights provisions of the Basic Law.

BINDING EFFECT OF THE LEGISLATION

8. The amendments in the Bill do not affect the current binding effect of the existing provisions of various Ordinances covered by the Bill.

FINANCIAL AND STAFFING IMPLICATIONS

9. There are no financial or staffing implications arising from the Bill.

PUBLIC CONSULTATION

10. Since the amendments are essentially straightforward adaptations, consultation with the public is not considered necessary.

PUBLICITY

- 11. A press release will be issued on 15 January 1999 when the Bill is gazetted.

To

Adapt certain Ordinances to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

Enacted by the Legislative Council.

1. Short title

This Ordinance may be cited as the Adaptation of Laws Ordinance 1999.

2. Commencement

- (1) This Ordinance shall be deemed to have come into operation on 1 July 1997.
- (2) Subsection (1) shall be subject to Article 12 of the Hong Kong Bill of Rights set out in Part II of the Hong Kong Bill of Rights Ordinance (Cap. 383).

3. Amendment of Ordinances

The Ordinances specified in the Schedules are amended in the manner indicated in those Schedules.
