# **ADAPTATION OF LAWS (NO. 14) BILL 1999**

#### INTRODUCTION

At the meeting of the Executive Council on 27 April 1999, the Council ADVISED and the Chief Executive ORDERED that the Adaptation of Laws (No. 14) Bill 1999, at the Annex, should be introduced into the Legislative Council.

## **BACKGROUND AND ARGUMENT**

2. There are provisions in the above-mentioned Ordinances which are inconsistent with the Basic Law or with Hong Kong's status as a Special Administrative Region of the People's Republic of China. The Adaptation of Laws (No.17) Bill 1999 seeks to adapt these provisions with a view to bringing them into conformity with the Basic Law and Hong Kong's present status.

#### THE BILL

- 3. The proposed amendments are mainly terminological changes, e.g. references to "the Colony", "立法局" and "行政局" are replaced by "Hong Kong", "立法會" and "行政會議" respectively. Similarly, a reference to the "Governor" will be replaced by the "Chief Executive". Where a provision previously conferred power on the "Governor" to make subsidiary legislation, the reference to the "Governor" will still be adapted to the "Chief Executive". Although the requirement under Article 56 of the Basic Law that the Chief Executive shall consult the Executive Council before making subordinate legislation is then not expressly set out, the Council will still have to be consulted if the Chief Executive is to exercise this legislative function.
- 4. The second reference to the "Governor in Council" in section 10(1) of the New Territories Ordinance (Chapter. 97) is a historic reference and, as such, is a reference that would not normally be adapted. However in this case it is appropriate to delete the historic reference to maintain consistency with the adaptation of the first reference. References to the "Crown" (Item 1 of Schedule 2, Item 6 of Schedule 3, Items 2 and 4 of Schedule 7, Items 2 and 4 of Schedule 8 and Item 1 of Schedule 10) are all, on the basis of the context in which they occur, uniformly adapted to "Government" as being provisions affecting and being the sole responsibility of the Government of the Hong Kong Special Administrative Region.

## **COMMENCEMENT**

5. The Bill provides that, subject to Article 12 of the Hong Kong Bill of Rights, the adaptations when passed into law shall take effect retrospectively, as from the date of the establishment of the Hong Kong Special Administrative Region.

## LEGISLATIVE TIMETABLE

6. The proposed legislative timetable is as follows -

Publication in the Gazette 7 May 1999

First Reading and commencemen 19 May 1999 of Second Reading debate

Resumption of Second Reading to be notified debate, committee stage and Third Reading

## **HUMAN RIGHTS IMPLICATIONS**

7. The Department of Justice has confirmed that the Bill is consistent with the human rights provisions of the Basic Law.

## BINDING EFFECT OF THE LEGISLATION

8. The amendments will not affect the current binding effect of the existing provisions of various Ordinances covered by the Bill.

## FINANCIAL AND STAFFING IMPLICATIONS

9. There are no financial or staffing implications arising from the Bill.

## **PUBLICITY**

10. A press release will be issued on 7 May 1999 (date of Gazette). A spokesman will be available to handle media enquiries.

#### A BILL

To

Adapt certain Ordinances to bring them into conformity with the Basic Law and with the status of Hong Kong as a Special Administrative Region of the People's Republic of China.

Enacted by the Legislative Council.

#### 1. Short title

This Ordinance may be cited as the Adaptation of Laws (No. 14) Ordinance 1999.

#### 2. Commencement

- (1) This Ordinance shall be deemed to have come into operation on 1 July 1997.
- (2) Subsection (1) shall be subject to Article 12 of the Hong Kong Bill of Rights set out in Part II of the Hong Kong Bill of Rights Ordinance (Cap. 383).

#### 3. Amendment of Ordinances

The Ordinances specified in the Schedules are amended in the manner indicated in those Schedules.

#### NEW TERRITORIES ORDINANCE

1. Section 3 of the New Territories Ordinance (Cap. 97) is amended by repealing "Governor" where it twice appears and substituting "Chief Executive".
