#(1) 許長青議員 (書面答覆)

- (c) 有否發現來往中港兩地的大型貨車,在內地購入劣質柴油回港 使用的情況;若有,有否評估該做法對本港空氣質素的影響, 以及當局有何措施防止該做法?

In this connection, will the Government inform this Council whether it has similar plans to establish such facility in Hong Kong, particularly for Chinese medicine; if it has such plans, the steps it will take to ensure its competitiveness among drug evaluation centres in the region; if not, the reasons for that?

Disposal of unused blood by the Red Cross

- (d) whether there will be changes to the port development plans in Lantau Island; if so, the alternative locations of port facilities?

青年人對知識產權的認識

#(8) <u>Dr Hon David LI</u> (Written reply)

It is reported that a survey conducted by the Federation of Youth Groups found, almost half of the young people interviewed believe there is nothing wrong in buying pirated goods, one third had no idea that laws protecting intellectual property rights have been enacted and one third think a thriving black market in fake items could help reviving the economy. In this connection, will the Government inform this Council whether:

- (a) it will step up efforts in promoting the importance of protection of intellectual property rights in primary and secondary schools; and
- (b) it will consider launching specific educational programmes and providing additional funding for such programmes?

Unauthorized change of bus routes

- (b) whether the Airport Authority has plans to designate such a pick-up area for private cars; if not, the reasons for that; and
- (c) given that arriving passengers have to walk from the arrival hall to the car park, whether the Airport Authority will consider providing more convenient arrangements for picking up VIPs such as delegates of business leaders?
