Government rates on vacant commercial premises

#(1) 朱幼麟議員 (口頭答覆)

政府可否告知本會:

- (a) 爲何在 95 年 7 月取消對空置的商用樓宇免收差餉措施;及
- (b) 鑑於現今香港經濟疲弱,物業市道不佳,政府會否考慮再次實施該等措施,並將範圍擴闊至包括住宅樓宇;如會,具體計劃如何;如否,理由爲何?

Wrongful grant of child care centre fee assistance

#(2) 周梁淑怡議員 (口頭答覆)

政府可否告知本會:

- (a) 是否錯誤批出「幼兒中心繳費資助」給外籍傭工;原因何在;
- (b) 繼錯誤批出綜緩金予億萬富翁之後,又錯誤批出幼兒資助予外籍傭工,政府部門的資助撥款批核及監察制度是否有檢討的必要;及
- (c) 有否統計錯誤批出的個案數目及花費款項?

Train services of Airport Express and Tung Chung line

#(3) 陳榮燦議員 (口頭答覆)

機場快線及東涌線列車自從開始投入服務以來,政府可否告知本會:

- (a) 兩線列車運作如何,電腦訊號系統運作如何;

- (c) 兩線列車的乘客量分別爲何;及
- (d) 何時會增加列車班次?

Utilization of cross-harbour tunnels

#(4) 何俊仁議員 (口頭答覆)

雖然現時有3條過海隧道(紅隧、東隧、西隧),但由於收費不同, 令部份隧道之使用量偏低,以致未能於繁忙時段有效地疏道紅隧之擠 塞情況。爲此,政府可否告知本會:

- (a) 3條過海隧道原先設計可承擔之交通流量如何;
- (b) 現時 3 條過海隧道在繁忙時段之交通流量如何;較設計上可承 擔之交通流量相差多少;
- (c) 在東隧和西隧通車後,對紓緩紅隧擠塞之成效如何;
- (d) 現時西隧在繁忙時段使用量偏低是否造成社會資源浪費;及
- (e) 政府會否採取措施,例如調節 3 條過海隧道之收費,令它們能 更有效地被使用,進一步改善現時繁忙時段紅隧的擠塞情況?

Review of restrictions on installation of neon signboards electronic flashing signboards

#(5) 楊孝華議員 (口頭答覆)

以前政府因航機安全問題而嚴加規管霓虹光管招牌或電子閃動招牌的裝置,但機場現已遷離市區,政府可否告知本會,政府在短期內會否加速檢討此法例,對裝置這類招牌的限制放寬;若然,現在進展情況如何;若否,原因何在,是否有其他因素限制?

Legislation on carriage of bulky machinery

#(6) 何鍾泰議員 (口頭答覆)

較早前,西貢公路南圍段,一輛載著巨型石屎打樁機的貨櫃拖頭及拖架,在彎位失控,將打樁機拋出車外,擊中鄰線迎面的一部私家車,造成兩死兩傷的慘劇。就此,政府可否告知本會:

- (a) 現時是否有嚴格的法例及安全標準監管運載重型機械的貨櫃拖 頭及拖架裝置;
- (b) 同時,當局有甚麼措施去監管運載工程機械的程序和安全標準,以確保道路使用者的安全;及
- (c) 若有,當局是否有嚴格執行有關的法例及安全標準?

Utilization of Western Harbour Crossing

僱員補償援助基金

#(8) <u>Hon Bernard CHAN</u> (Written reply)

According to the 1996/97 annual report of the Employees' Compensation Assistance Fund Board (the Board), a total of 108 applications were settled at a cost of \$84 million from 1991 to 1997. Mr Justice Cheung suggested in Lai Chi Pon Vs Toto Steel & Iron works Ltd & Others (PI No 1149 of 1995) on 12 March 1997 that "the resources of the Fund can in fact be enhanced if the Board can take a more active role and enter into settlement negotiations with the plaintiff". Will the Government inform this Council:

- (a) how many cases were settled in 1997/98 and are still pending as from 1 April 1998;
- (b) how much did the settlements cost in 1997/98;
- (c) the Fund surplus as at 31 March 1998;
- (d) whether the surplus is adequate to deal with the pending cases; and
- (e) whether the Board will consider entering into settlement negotiations as suggested by Mr Justice Cheung?

Improvement works to Sai Kung Road

#(9) 劉健儀議員 (書面答覆)

本年 7 月 19 日在西貢公路南圍段發生一宗嚴重交通意外,導致兩人 死 4 人傷。就此,政府可否告知本會:

- (a) 過去 3 年,在西貢公路發生的交通意外數字爲何;
- (b) 有否計劃改善西貢公路多處危險急彎,特別是清水灣道進入西 貢公路一段、該公路的南圍段、北圍段及蠔涌段;若有,計劃 的詳情爲何;若否,原因爲何;
- (c) 在未完成道路改善工程前,會否考慮禁止重型貨車使用西貢公路,而改用較平坦的西沙公路進出西貢;及
- (d) 會否考慮全面擴闊西貢公路,以改善西貢至市區的交通?

Employment of people with a disability

Water supply to Hong Kong from the mainland

- (d) 以往入境事務處(人民入境事務處)簽發了「無結婚紀錄證明書」是否具有法律效力;若否,政府會如何補救?

In regard to the recent reports that patients requiring emergency medical treatment in the Chek Lap Kok Airport, including those on flight in the tarmac, would have to be charged before being treated, would the Administration inform this Council:

- (a) the rationale for charging patients requiring emergency medical service;
- (b) the number of private doctors commissioned by the Airport Authority to provide such medical service;
- (c) the level of charges and the criteria for receiving such services;
- (d) the target time of arrival, if any, upon receiving emergency call, for ambulances to reach the patients; and
- (e) whether it would consider asking the Port Health Section at the Airport to take up such emergency task?

Impact of the court's ruling on the enforcement of "CIETAC"'s decisions in Hong Kong

#(14) 曾鈺成議員 (書面答覆)

今年初本港高院一宗案件內,范達理法官以香港成爲特區後,紐約公約不再適用爲由,判令「中國國際經濟貿易仲裁委員會」(CIETAC)所作的仲裁裁決,於回歸後不能在港法院申請執行。鑑於有關判令對香港經貿地位的影響引起關注,政府可否告知本會:

- (a) 若紐約公約簽署國的仲裁裁決不能在港執行,會否影響本港作 爲金融、貿易及仲裁中心的地位;港府將作出甚麼措施補救;
- (b) 有關判令是否具有追溯力,即是否適用於回歸前已簽署載有 CIETAC 仲裁條款的合同;若這批合同發生問題申請仲裁, CIETAC 對此作出仲裁裁決,但本港法院又不批准有關裁決執行 時,港府將如何協助合同受害人;及
- (c) 本港現行的仲裁法規定,凡紐約公約簽署國之國際仲裁(包括 CIETAC)的裁決,均可由香港法院頒布命令執行。上述判令是 否影響到本港仲裁法的執行;影響範圍有多大?

政府醫院病牀不足

#(15) <u>Dr Hon David LI</u> (Written reply)

It is reported that Queen Mary Hospital has added canvas beds to its 47-bed women's ward, which now houses more than 60 patients per day. A Hospital Authority spokesman said overcrowding was also a problem at other hospitals as demand for medical care among elderly patients has out-paced the increase in beds. Will the Government advise this Council:

- (a) whether patients who need to stay in hospitals for comprehensive treatment and observation are being released early due to the shortage of beds;
- (b) to what extent has the overcrowding situation affected the efficiency and morale of the front-line medical staff; and
- (c) will the Hospital Authority consider any long-term solutions to solve the problem of overcrowded government hospitals?

Allocation of schools places for Form 6 students
