1. Arrangement of Statutes

The Statutes of the University of Hong Kong in the Schedule to the University of Hong Kong Ordinance (Cap. 1053) is amended, in the Arrangement of Statutes, by repealing "Dean of Students" and substituting "Dean of Student Affairs".

2. Degrees and other academic distinctions

Statute III is amended---

(a) in paragraph 1(a), by adding---

"Bachelor of Accounting

Bachelor of Economics and Finance

Bachelor of Engineering, in engineering disciplines as determined by the Senate from time to time

Bachelor of Housing Management

Bachelor of Management Studies

Bachelor of Science (Sports Science and Leisure Management)

Bachelor of Traditional Chinese Medicine";

(b) in paragraph 1(b), by adding---

"Master of Business Administration (International)

Master of Science in Engineering, in engineering disciplines as determined by the Senate from time to time";

(c) in paragraph 1(c), by adding---

"Doctor of Legal Science";

(d) in paragraph 2(a), by adding---

"Postgraduate Diploma in Engineering, in engineering disciplines as determined by the Senate from time to time

Postgraduate Diploma in General Dental Surgery".

3. Members of the University

Statute IV is amended, in paragraph 1(ca), by repealing "Dean of Students" and substituting "Dean of Student Affairs".

4. The Dean of Student Affairs

Statute IXA is amended---

(a) in the heading, by repealing "Dean of Students" and substituting "Dean of Student Affairs";

- (b) in paragraphs 1 and 2, by repealing "Dean of Students" and substituting "Dean of Student Affairs".
- 5. The Registrar and other officers

Statute X is amended, in paragraphs 2(c) and 4(b) and (c), by repealing "Registrar" wherever it appears and substituting "Vice-Chancellor".

6. The Court

Statute XV is amended---

- (a) in paragraph 1(d) (iv) and (v), by adding "from among its number" after "Council";
- (b) in paragraph 9---
- (i) by repealing "by the Standing Committee of Convocation" and substituting "under paragraph 1(d)(i), (ii), (iv) or (v) of this Statute";
- (ii) in subparagraph (a), by repealing "that committee" and substituting "the body which elected him".
- 7. The Council

Statute XVIII is amended, in paragraph 1(fa), by repealing "Dean of Students" and substituting "Dean of Student Affairs".

8. The Senate

Statute XXII is amended, in paragraph 1---

- (a) by adding---
- "(ic) the Dean of the Graduate School;";
- (b) in subparagraph (k), by repealing "Dean of Students" and substituting "Dean of Student Affairs".
- 9. Convocation

Statute XXVIII is amended, in paragraph 1(1)(a), by repealing "Dean of Students" and substituting "Dean of Student Affairs".

10. The Disciplinary Committee

Statute XXX is amended, in paragraph 3(4), by repealing "Dean of Students" and substituting "Dean of Student Affairs".

Explanatory Note

These Statutes amend the Statutes of the University of Hong Kong in the Schedule to the University of Hong Kong Ordinance (Cap. 1053) to---

(a) allow the University to confer or award the following degrees and academic distinctions---

Bachelor of Accounting

Bachelor of Economics and Finance

Bachelor of Engineering, in engineering disciplines as determined by the Senate from time to time

Bachelor of Housing Management

Bachelor of Management Studies

Bachelor of Science (Sports Science and Leisure Management)

Bachelor of Traditional Chinese Medicine

Master of Business Administration (International)

Master of Science in Engineering, in engineering disciplines as determined by the Senate from time to time

Doctor of Legal Science

Postgraduate Diploma in Engineering, in engineering disciplines as determined by the Senate from time to time

Postgraduate Diploma in General Dental Surgery;

- (b) change the title of "Dean of Students" to "Dean of Student Affairs";
- (c) provide that the Director of Estates and the Director of Finance shall be responsible to the Vice-Chancellor instead of the Registrar;
- (d) provide that members elected to the Court by the Grant Schools Council and the Hong Kong Subsidized Secondary Schools Council shall be members of the respective Councils:
- (e) clarify the status of some categories of elected members to the Court so that an elected member under such categories---
- (i) shall be deemed to have resigned from the Court if he ceases to be a member of the body which elected him;
- (ii) shall be deemed to have resigned from his membership in his original capacity if he becomes a member of the Court in another capacity; and
- (f) revise the composition of the Senate to allow for official representation from the Graduate School.
