MILK (URBAN COUNCIL) (AMENDMENT) BYLAW 1998

(Made by the Provisional Urban Council under sections 56 and 56B of the Public Health and Municipal Services Ordinance (Cap. 132))

1. Interpretation

Bylaw 3 of the Milk (Urban Council) Bylaws (Cap. 132 sub. leg.) is amended--

- (a) by repealing the definition of "licence";
- (b) by adding---
- " "full licence" (正式牌照) means a licence granted under bylaw 16;
  - "licence" (牌照) means a full licence or a provisional licence;
  - "licensee" (持牌人) means a person to whom a licence has been granted;
  - "provisional licence" (暫准牌照) means a licence granted under bylaw 16A;".
- 2. Application for licence

Bylaw 15(1) is amended by repealing "such" where it first appears.

3. Full licence

Bylaw 16 is amended---

- (a) by renumbering it as bylaw 16(1);
- (b) in paragraph (1)---
  - (i) by repealing everything before subparagraph (a) and substituting---
- "(1) The Council may, on application made in respect of any premises, grant a full licence permitting the carrying on of a business as a milk factory where the applicant satisfies the Council that the following conditions have been satisfied in relation to the premises---";
- (ii) in subparagraph (e)(iii), by repealing "subparagraph (i)" and substituting "sub-subparagraph (i)";
  - (iii) in subparagraph (g), by repealing "and" at the end;
- (iv) in subparagraph (h), by repealing the full stop and substituting a semicolon;
  - (v) by adding---
- "(i) any plant or apparatus used for the heat-treatment of milk or any milk beverage is of a type approved by the Council; and
- (j) any requirements issued by the Director of Fire Services have been complied with.";
- (c) by adding---
- "(2) A full licence shall be valid for a period of 12 months from and including the date of its grant.".
- 4. By law added

The following is added---

## "16A. Provisional licence

- (1) The Council may, on application made in respect of any premises, grant a provisional licence permitting the carrying on of a business as a milk factory where the applicant satisfies the Council that the conditions mentioned in bylaw 16(1)(b) to (j) have been satisfied in relation to the premises.
- (2) The Council shall not consider an application for a provisional licence unless the applicant has applied to the Council for a full licence in respect of the same premises.
- (3) Subject to paragraph (6), a provisional licence shall be valid for a period of 6 months from and including the date of its grant.
- (4) A provisional licence may be renewed on only one occasion at the absolute discretion of the Council.
- (5) Subject to paragraph (6), a provisional licence that is renewed under paragraph (4) shall be valid for a period of 6 months from and including the date of its renewal or such lesser period as may be specified in the provisional licence.
- (6) If a full licence is granted during the validity of a provisional licence, the provisional licence shall expire upon the grant of the full licence. The fee paid in respect of the provisional licence shall be refunded on a pro-rata basis by reference to the number of days of the remaining part of the validity period of the provisional licence. Any fraction of \$1 in the refund shall count as \$1.".
- 5. Restriction on alterations or additions
- to licensed premises

Bylaw 17 is amended by repealing "such".

6. By law added

The following is added---

"17A. Transfer of licence

Save with the consent in writing of the Council, a person to whom a licence is granted under this Part shall not transfer his licence to any other person.".

7. Fees and duplicate licence

Bylaw 39 is amended---

- (a) by repealing paragraph (1);
- (b) in paragraph (2), by repealing "any such licence" and substituting "a full licence";
- (c) by adding---
- "(2A) Subject to bylaw 16A(6), the fee for the grant or renewal of a provisional licence shall be half of the appropriate fee for a full licence.";
- (d) in paragraph (3), by repealing "such" where it first appears.
