A survey conducted by the Hong Kong Federation of Education Workers on 58 schools that have information technology co-ordinators, showed that such person was necessary for schools to promote IT education. Will the Government consider implementing the "one co-ordinator for one school" policy to enhance Hong Kong students' competitiveness in meeting the challenges of the information era?

# (5) Hon Christine LOH (Written reply)

Proposals have been made to build incinerators to burn clinical waste, municipal waste and sewage sludge, all of which are known to emit dioxins (2 families of compounds PCDDs - polychlorinated dibenzo dioxins and PCDFs - polychlorinated dibenzo furans). In order to consider what significance such increments of dioxin exposure may have for the health of the citizens of Hong Kong, it is important to know the current body burdens. In this connection, will the Government inform this Council:

- (a) of its current understanding of the importance of the meaning of current body burdens;
  - (b) of the current levels of dioxin in body fat and in mother's breast milk; and
  - (c) how these levels compare to the levels in other countries as compiled by the World Health Organization ("WHO")?

- (二) 當局為轄下 106 個興建中的地盤覆檢樁柱的時間表為何；已完成的屋苑及檢驗其結果為何；
- (三) 當局會否考慮覆檢現時已建成及入伙的公營房屋結構問題；若不會，原因為何；
- (四) 有否評估該屋苑因短樁而引起的補救工程費用為何，以及何時完成；及
- (五) 有否調查公營房屋多宗短樁事件是否涉及房屋署職員；當局就改革監管工程質素現時制度現時的進展為何？

# (8) Hon Christine LOH (Written reply)

The aim of the Government's stated policy on radio frequency spectrum management is to "ensure efficient planning and utilisation of the radio frequency spectrum within Hong Kong." Will the Administration inform this Council whether:

- (a) it will consider giving RTHK Radio 3 an FM frequency for clearer transmission as this is Hong Kong's main local English language channel and that improved clarity will benefit all English language listeners;
- (b) it will consider granting new frequencies to more commercial broadcasters to enable a more lively and diverse radio service provision; and
- (c) it will consider new frequencies to non-commercial/community based organizations to provide a richer civic environment?

- (一) 當局未有派員出席聯合國有關會議的原因為何；又以往聯合國舉行的各類型會議，港府事前會否得悉；若會，是透過何種途徑；
- (二) 若日後聯合國再次舉辦同類型的會議，當局會否派員出席；若否，原因為何；
- (三) 是否知悉該會議的議題；及有哪些國家的代表出席該次會議；又會議的成果及結論為何；及
- (四) 衛生福利局局長在答覆本會於去年 5 月 12 日的口頭質詢時表示，就基因食物的管制事宜，政府在考慮本地的管制方法時，會參考國際權威組織，如聯合國糧食及農業組織及世界衛生組織等。就此，聯合國是次會議所得的結論，政府會否加以利用作為研究實施基因標籤制的一部分及用作參考制訂其他監管法例；若聯合國一旦通過全面禁止基因食品進口，政府會否考慮該等建議；若否，原因為何？
