Exchanges and Clearing Houses (Merger) Bill

At the Bills Committee meeting held this morning, we undertook to propose a list relevant market and professionsal bodies for cosultation by the Bills Committee.

As noted by Mr. Bryan Chan at this morining's meeting, a Coordinating Committee on Market Structure Reform (CCMSR) was formed in May this year to provide a forum for the relevant parties to exchange views on key issues relating to the reform and to clarify issues raised by the industry. The membership of the Committee comprises the former and current chairmen of the two Exchanges, chairman of the Hong Kong Securities and Clearing Company, market leaders and participants, representatives of the Hong Kong Association of Banks as well as the Securities and Futures Commission. A full membership list of the Committee is attached for your reference. The exercise has received considerable public attention since the announcement by the Financial Secretary and we have received feedback from the market on the reform

from time to time. We have not therefore specifically consulted other market and professional bodies.

Meanwhile, I understand that the Bills Committee had earlier consulted a number of market and professional bodies on the Securities (Margin Financing) Bill 1999. In view of the current concern of members about the consultation on the Merger Bill, you may wish to consier if the same list of bodies (as per attahced) should be invited to give views on the Merger Bill for consideration by the Bills Committee. As you know, the Law Society has already made a submission on the Bill to which we have responded via our letter dated 25 November.
