- Question: What measures will be taken by the Office for its plan to sever its link with the civil service and what are the resource implications?
- Asked by : The Hon. Ronald Arculli

<u>Reply</u>: Under the delinking proposal, the Office will take over and operate its own administrative and financial support systems. It will recruit its own staff to replace civil servants serving on secondment to the Office. In concrete terms, this will involve:

- establishing new systems for human resource management
- > establishing new systems for financial management and control;
- formulating recruitment policies; and
- formulating new terms and conditions of appointment for contract staff of the Office.

As the delinking proposals have not yet been discussed with the Administration, it is not possible to make a precise estimate of funding requirements beyond 2000/2001. However, in formulating proposals on the terms and conditions of appointment for staff of the Office, the Office will make reference to the pay and fringe benefit packages of other independent public organizations being funded by the general revenue. Where it is more cost-effective to do so, the Office intends to continue using support services currently being provided by Government departments. Apart from some commissioning costs, it is not expected that delinking will result in any significant net increase in the Office's expenditure. However, from a book keeping point of view, there will be significant increases in the accounts of the Office, which will have to be revamped to incorporate certain expenditure items that have hitherto been provided out of various departmental accounts throughout the civil service. These will primarily be accounting arrangements and would not

involve increased expenditure.

- Question: The Office of The Ombudsman plans to delink further from the civil service so as to strengthen its independence. What is the timetable of this delinking exercise? What will be the amount of savings achieved or additional resources required by the Office?
- <u>Asked by</u>: The Hon. Albert HO Chun-yan
- Reply :The Ombudsman's working target is to commence delinking on 1 April
2001. Under current plans, the Office will take over and operate its own
administrative and financial support systems from that day. It will
recruit its own staff to replace some civil servants now serving on
secondment to the Office. The Ombudsman intends that the Office will
eventually be staffed predominantly by its own appointees. It is
expected that until the Office has built up a sufficient level of expertise, a
number of civil service secondees will be retained for sometime after
delinking. The Office will discuss with heads of grades concerned on the
phased transfer of civil servants back to the civil service.

As the delinking proposals have not yet been discussed with the Administration, it is not possible to make a precise estimate of funding requirements beyond 2000/2001. However, in formulating proposals on the terms and conditions of appointment for staff of the Office, the Office will make reference to the pay and fringe benefit packages of other independent public organizations being funded by the general revenue. Where it is more cost-effective to do so, the Office intends to continue using support services currently being provided by Government departments. Apart from some commissioning costs, it is not expected that delinking will result in any significant net increase in the Office's expenditure. However, from a book keeping point of view, there will be significant increases in the accounts of the Office, which will have to be revamped to incorporate certain expenditure items that have hitherto been

- <u>Reply</u>: The increase of about \$10M under Subhead 000 is made up as follows:

\$5M	This amount, comprising \$4M in salaries and
	\$1M in cash allowances in lieu of fringe
	benefits, is earmarked for the appointment of
	non-civil service contract staff in 2000/2001.
	This amount is currently included under the

	serving civil servants and the central vote for
	their fringe benefits.

- \$2M End-of-contract gratuities for 5 non-civil service contract officers completing their contracts with the Office within the year.
- \$2M Earmarked for the creation of 1 Senior Complaints Officer and 1 Complaints Officer posts and the upgrading of 2 existing posts of Complaints Officer to Senior Complaints Officer in 2000/2001.
- \$0.7M This entry, which is being offset by an equivalent deletion from the central vote, is in

respect of housing and passage allowances for The Ombudsman. As The Ombudsman is a non-civil service appointee, allowances relevant to the post should be transferred to this Office's head of expenditure so as to give a complete picture of the funding requirement of the Office.
