HEAD 703 - BUILDINGS

New Items - Committed projects of the two Provisional Municipal Councils

Members are invited to recommend the Finance Committee to approve -

- (a) the creation and direct inclusion of 149 projects contracted by the Provisional Municipal Councils with a total outstanding commitment of \$5,037.77 million in money-of-the-day prices into Category A of the Public Works Programme;
- (b) the creation and direct inclusion of 3 098 minor items contracted by the Provisional Municipal Councils with a total outstanding commitment of \$367.21 million in money-of-the-day prices into Category D of the Public Works Programme; and
- (c) an increase in Capital Works Reserve Fund Head 703 subhead **3004GX** from \$1,100 million by \$43 million to \$1,143 million to accommodate the anticipated increase in expenditure under this subhead for the remainder of the current financial year as a result of (b) above.

/PROBLEM

PROBLEM

- 2. The Provisional Urban Council (PUC) and Provisional Regional Council (Pro RC) have entered into contractual commitments for the delivery of 149 capital works projects, including -
 - (a) 110 completed projects with outstanding accounts yet to be settled; and
 - (b) 39 projects under construction or which have not yet started but involve contractual obligations.
- 3. In addition, the two Councils have entered into contractual commitments with regard to 298 "minor works projects¹" and 2 800 "minor works items²", hereafter referred to as "minor items".
- 4. Upon the dissolution of the two Provisional Municipal Councils (PMCs) on 31 December 1999 and the re-organization of the related Municipal Departments on 1 January 2000, management of the above projects together with their outstanding financial obligations will become the responsibility of two new departments, namely, the Food and Environmental Hygiene Department (FEHD) and the Leisure and Cultural Services Department (LCSD) yet to be established. We need to set aside an allocation under the Capital Works Reserve Fund (CWRF) for completing the outstanding works and fulfilling the contractual obligations incurred.

PROPOSAL

5. The Head, Task Force on Re-organization of Municipal Services and the Secretary for Home Affairs propose to include the 149 capital works projects (referred to in paragraph 2 above) into Category A, the 3 098 minor items (referred to in paragraph 3 above) into Category D of the Public Works Programme, with a total funding allocation of \$5,404.98 million in money-of-the-day (MOD) prices to fund capital works projects and minor items for which the two PMCs have already entered into contractual commitments.

/PROJECT

[&]quot;Minor works projects" include PUC projects each not exceeding \$15 million and Pro RC projects each not exceeding \$7.5 million.

² "Minor works items" include PUC projects each not exceeding \$0.3 million and Pro RC projects each not exceeding \$0.5 million.

PROJECT SCOPE AND NATURE

- 6. The funding sought in this paper covers all outstanding contractual commitments in relation to -
 - (a) 110 completed projects, broken down as follows -

The total outstanding contractual commitment is estimated to be \$621 million;

The total outstanding contractual commitment is estimated to be \$4,417 million⁴ in MOD prices; and

(c) 298 "minor works projects" with a total outstanding contractual commitment of some \$316 million, and 2 800 "minor works items" with a total outstanding commitment of \$52 million. With effect from 1 January 2000, expenditure on these items will be met from CWRF block allocations subheads 3004GX, 3100GX and 3101GX under Head 703.

/Details

Multi-function complexes containing a mix of environmental hygiene and leisure and cultural facilities are grouped under the Environmental Hygiene category in this submission.

Includes \$169 million for furniture and equipment for the Museum of History and the Museum of Coastal Defence. The construction of these museums has already been funded under the CWRF but the cost for furniture and equipment is currently borne by the PUC.

Details of the projects covered in (a) and (b) above are set out in Enclosures A and B respectively.

JUSTIFICATION

- 7. The Provision of Municipal Services (Re-organization) Bill which was passed by the Legislative Council on 2 December 1999 provides, *inter alia*, that all property, rights and liabilities of the Councils will be vested in the Government as from the appointed day set out in the Bill. From that date all financial commitments entered into by the PMCs will be honoured by Government. To enable Government to fully discharge this obligation, we need to set aside \$5,404.98 million in MOD prices from the CWRF to complete works projects for which the two PMCs have entered into contractual commitments.
- 8. Funding for the 149 capital works projects is approved on an individual project basis under the CWRF. Minor items (as defined in paragraph 3 above) are funded under block allocations. Funding provision for CWRF block allocations is approved on an annual basis by the Finance Committee. Having reviewed the spending position of the three block allocations under Head 703 for which he is the controlling officer, the Director of Architectural Services concluded that the approved allocations for 1999-2000 for subheads **3100GX** and **3101GX** will be adequate to meet the forecast expenditure arising from PMC minor items for the remainder of the current financial year. However, there is an anticipated shortfall of \$43 million for subhead **3004GX** and supplementary provision equal to such an amount will be necessary.

FINANCIAL IMPLICATIONS

9. We estimate that the total outstanding contractual commitments on all the projects stated in paragraph 4 above amounts to \$5,404.98 million in MOD prices.

12. There are no environmental implications arising from this proposal.

LAND ACQUISITION

13. This proposal involves no land acquisition.

ADDITIONAL INFORMATION

14. With the dissolution of the two PMCs, the new FEHD and LCSD will implement the committed projects to fulfil the various contractual obligations involved and ensure completion of the projects in a timely manner. Subject to the endorsement of the future Secretary for the Environment and Food and the Secretary for Home Affairs, PMC projects under planning will be admitted into the Government's Public Works Programme. We will give careful consideration to when these projects will be taken forward, giving due weight to their readiness to proceed, their costs and Government's overall funding situation.
