Some of the Fairview Park premises not granted occupation permits

#(1) 譚耀宗議員 (書面答覆)

據報,元朗錦繡花園部分單位並未獲當局簽發佔用許可證(俗稱"入伙紙")而只獲發"入伙證明書",有關業主可能因而無法出售該等單位。就此,政府可否告知本會:

- (一) 現時該屋苑獲發入伙紙及入伙證明書的單位數目分別爲何;部份單位未獲發入伙紙的原因爲何;
- (二) 當局向有關單位發出入伙證明書的法律依 據爲何;
- (三) 獲發入伙紙及入伙證明書的單位,在建築物的合法性及業權完整性方面有否不同;若有不同,詳情爲何;及
- (四) 當局有何措施消除該等業主的疑慮?

Potential breach of Article 144 of the Basic Law by the new subsidy arrangement for welfare NGOs

Extension of structural safety guarantee for HOS flats

#(5) 劉江華議員 (書面答覆)

政府計劃向天水圍所有出售的公營房屋單位,提供為期 20 年的結構安全保證,該保證期較現時向其他出售單位提供的 10 年結構安全保證期高一倍。就此,政府可否告知本會:

- (一) 當局會考慮甚麼因素,以決定是否延長其他 居者有其屋("居屋")屋苑的結構安全保 證期;及
- (二) 當局會否考慮延長其他發現結構問題的居 屋屋苑的結構安全保證期,例如馬鞍山錦豐 苑及將軍澳唐明苑;若否,原因爲何?

發展鐵路以取代七號幹綫

(6) Hon Christine LOH (Written reply)

With reference to the Government's stated transport policy of using railways as the first choice to meet passenger traffic demand wherever practicable and the ongoing studies to develop the Route 7 highway, which will connect Aberdeen and Kennedy Town, will the Government inform this Council:

- (a) the respective costs incurred so far on feasibility, engineering and environmental studies conducted specifically on Route 7 highway;
- (b) the quantity and proportion of freight traffic that is expected to use Route 7;
- (c) the quantity and proportion of private vehicles expected to use Route 7;
- (d) whether it has assessed if the development of Route 7 is consistent with Government policy of discouraging private car use;
- (e) whether it has conducted a detailed feasibility study of constructing a Mass Transit Railway ("MTR") South Island line as an alternative to Route 7, to meet the traffic demand in the Southern district; if not, of the reasons for that:
- (f) the respective costs of feasibility, engineering and environmental studies conducted on the railway option;
- (g) how the direct costs to the Government in the construction of Route 7 compare to building an MTR South Island line;
- (h) whether it has evaluated the reduction in traffic that will be brought about by a railway on existing roads in the Southern, and whether this would provide sufficient additional capacity to accommodate the growth in freight traffic;
- (i) of the criteria it uses to evaluate road-based versus rail-based options, and the respective weights given to each criterion;
- (j) whether it will consider the overall economic rather than simply the financial aspects of railways versus road projects, and how such economic factors will be included in the final evaluation;
- (k) whether it has estimated the impact on property values of the two options within the area; if so, of the details; and
- (l) whether it has considered alternative uses for the shoreline between Aberdeen and Kennedy Town?

Decreasing number of CSSA cases

#(7) 劉慧卿議員 (書面答覆)

在 1998-1999 財政年度,屬失明、肢體傷殘及精神病患者類別的綜合社會保障援助計劃("綜援")受助人的數目分別爲 550,4313 及 9668。該等類別的綜援受助人數目在去年 5 月大幅下降並在往後數月一直維持於較低的水平:去年 5 月至 12 月該等類別的綜援受助人每月平均數目分別爲 291,2752 及8627。就此,行政機關可否告知本會:

- (一) 有否評估自去年 5 月起,該等類別的綜接受助人數目較過往顯著下降的原因爲何;及
- (二) 當局有否就該等類別的綜援受助人的傷殘 程度予以評級;若有,
 - (i) 評級的詳情及當局如何評核受助人屬哪一級;及
 - (ii) 按有關級別分類,去年全年每月屬 該等類別的綜援受助人數目分別爲 何?

Accident rate of minibuses

#(8) 劉江華議員 (書面答覆)

本年 2 月 10 日凌晨,在沙田發生一宗嚴重交通意外,一輛懷疑超速行駛的公共小巴與一輛私家車相撞,事件引致 1 死 13 傷。就此,政府可否告知本會:

- (一) 過去3年,每年涉及公共小巴的交通意外數字,及該數字佔同年交通意外總數的百分比為何;
- (二) 當局有否研究減低公共小巴乘客交通意外 傷亡率的方法,例如規定公共小巴的座位須 裝有安全帶;及
- (三) 過去3年,當局檢控公共小巴司機超速駕駛的個案數字爲何,並以超速每小時10公里爲一組別列出分項數字;會否加強執法行動,遏止公共小巴司機(尤其是在晚上及凌晨)超速駕駛?

Clearance of unauthorized rooftop structures

屋宇署計劃在本財政年度清拆400幢樓宇的外牆及天台僭建物。就此,政府可否告知本會:

- (一) 該 400 幢 樓 宇 的 地 區 分 布 和 涉 及 的 天 台 僭 建 物 數 目 爲 何 ;
- (二) 有否估計在該等樓宇當中,現時在土地註冊處有就業權轉讓作出登記的天台僭建物數目;當局會否考慮向該等有登記業權轉讓的僭建物業主作恩恤補償;若會,本年度所需款項爲何;若否,原因爲何;及
- (三) 當局會否安置該等天台僭建物的住戶及在 清拆前進行登記;若會,具體時間表爲何?

Internet users being trapped to pay distance call charges

#(10) 朱幼麟議員 (書面答覆)

據報,電訊管理局上月接獲約500宗互聯網用戶作出的投訴,他們聲稱在一些網站下載軟件後,該等軟件在他們不知情的情況下,把他們的電腦改以長途電話綫路重新撥號到外國的電子布告板系統,該等用戶因而需繳交有關長途電話費。就此,政府可否告知本會:

- (一) 是否知悉,投訴人使用過甚麼服務或下載過 甚麼軟件後引致上述情況;
- (二) 電訊管理局在上月接獲的投訴所涉及的網站數目;該等網站的內容主要屬甚麼類別;該等網站設在甚麼國家,以及當中有多少個在有關網頁上清楚說明該等軟件會把用戶的電腦以長途電話綫路接駁到外國網站;及
- (三) 當局有何措施提醒互聯網用戶避免墮入該 類陷阱?

Law enforcement against selling pork containing Clenbuterol

#(11) 何敏嘉議員 (書面答覆)

上月3日,將軍澳一間新鮮糧食店的經營者因售賣含有哮喘藥鹽酸克崙特羅的豬內被控及定罪,該個案屬首宗定罪個案。就此,政府可否告知本會:

- (一) 去年市民進食懷疑含鹽酸克崙特羅的豬肉 或豬內臟後身體不適入院治療的個案數 字;
- (二) 去年至今,當局共提出了多少次類似檢控, 直至上月初才有首宗成功定罪的個案的原因爲何;現正排期聆訊的個案數字;當局在 搜集證據及提出檢控方面有否遇到困難;若 有困難,詳情爲何;及
- (三) 當局有否追查該新鮮糧食店的含哮喘藥豬肉的來源;當局計劃訂定新規例,規管飼養 禽畜人士使用鹽酸克崙特羅及其他化學品 餵飼禽畜的工作進展爲何,以及立法建議的 詳情及具體時間表爲何?

政府可否告知本會,律政司法律草擬科在草擬有關規管金融市場的法例時,有否聘用熟悉金融市場運作的人士(例如專業會計師)提供專業意見,以確保擬訂立的法例能顧及市場的實際運作情況?

KMB not taking out full motor vehicle third party risk insurance

#(13) 鄧兆棠議員 (書面答覆)

據悉,九龍巴士有限公司("九巴")以特定賠償額作分界,以自行承保及保險公司承保兩種方式,處理「第三者保險」的申索。就此,政府可否告知本會:

- (一) 九巴是否根據《汽車保險(第三者)風險條例》(第 272 章第 4 條(c))的豁免條文,獲准以上述保險方式處理第三者保險的索償;若然,當局設立這豁免條文的立法原意爲何;若否,當局是根據甚麼條文,容許九巴選擇以有關方式處理第三者保險的索償;
- (二) 當局是否知悉九巴處理第三者保險索償的政策及機制運作的內容;若然,詳情爲何; 若否,原因爲何;
- (三) 當局有否評估,九巴以兩種方式處理索償的做法,相較其他專利巴士公司交由保險公司處理所有索償的做法,何者對申索人較有保障及公平;若然,結果爲何;若否,原因爲何;及
- (四) 是否知悉,過去3年,九巴每年以自行承保及保險公司承保方式,分別處理多少宗乘客或道路使用者的索償;當中不滿賠償方案而向九巴或政府部門投訴,或循民事索償的個案分別爲何?

長者宿位輪候情況

(14) Hon Bernard CHAN (Written reply)

The Social Welfare Department provides residential care services for the elderly including hostels, homes for the aged, care-and-attention homes and nursing homes. But there are repeated complaints that applicants have no wait for a long time before they are allocated with places. In this connection, will the Government inform this Council:

- (a) are there any applicants who had their names removed from the waiting list for those places because they died, or applicants who got selected but were found to be dead on selection; if yes, who many were the cases in recent years; and
- (b) on average how long is the waiting time for an applicant for different types of residential care services; and
- (c) will the Government shorten the waiting time?

(15) <u>Dr Hon David LI</u> (Written reply)

According to a survey conducted by the Hong Kong Young Women's Christian Association, many teachers surveyed felt extraordinary pressure in work and found serious difficulty in handling students' problems because they lacked the necessary experience, counselling skills and professional knowledge. In this connection, will the Government inform this Council of:

- (a) the progress of its plan to provide each Secondary School with one school social worker; and
- (b) the community resources available to teachers to assist them in coping with stress?
