Prison (Amendment) Rules 1999 (L.N. 254)

L.N. 250 - 254 repeal and re-enact the subsidiary legislation on welfare funds made under the Ordinances relating to five disciplined services, namely, the Customs and Excise Service, the Fire Services, the Immigration Service, the Police Force and the Correctional Services. L.N. 250 - 254 are made in consequence of the reconstitution of the welfare funds for members of those disciplined services following the enactment of the Disciplined Services Welfare Funds Legislation (Amendment) Ordinance 1999 (58 of 1999) ("the Amendment Ordinance").

The above Regulations and the Prison (Amendment) Rules provide for various matters relating to the administration of the welfare funds concerned following the constitution of the heads of the respective disciplined services as - 2 -

corporations sole in whom the welfare funds are vested. Those matters include maintenance of the welfare funds concerned, investment of surplus funds, audit of annual statement of accounts of the funds by the Director of Audit and the requirement for the audited statement of accounts to be laid on the table of the Legislative Council.

L.N. 250-254 will come into operation on the commencement of the amendments relating to the respective Ordinances on the disciplined services as set out in the Amendment Ordinance.

Public Health and Municipal Services Ordinance (Cap. 132)

Public Health and Municipal Services Ordinance (Public Pleasure Grounds)

(Amendment of Fourth Schedule) (No. 6) 1999 Order (L.N. 255)

This Order sets aside Tin Shui Road Park as a public pleasure ground in the Regional Council area. The effect of this Order is that the Public Health and Municipal Services Ordinance will apply to the new public pleasure ground.

Small Claims Tribunal Ordinance (Cap. 338)
Small Claims Tribunal (Amendment) Ordinance 1999 (28 of 1999)
(Commencement) Notice 1999 (L.N. 257)

This Notice appoints 19 October 1999 as the day on which the Small Claims Tribunal (Amendment) Ordinance 1999 (28 of 1999) will come into operation.

The Amendment Ordinance improves the scope and operation of the Small Claims Tribunal by providing for, among other things, the adjustment of the

Tribunal's jurisdiction from \$15,000 to \$50,000, legal representation in proceedings relating to insulting behaviour at the hearing of proceedings in the Tribunal, etc.

Telecommunication Ordinance (Cap. 106)
Telecommunication (Amendment) (No. 2) Regulation 1999 (L.N. 180 of 1999)
Commencement) Notice 1999 (L.N. 258)

This Notice appoints 15 October 1999 as the day on which the Telecommunication (Amendment) (No. 2) Regulation 1999 (L.N. 180 of 1999) will come into operation.

The Regulation expands the scope of services permitted to be received and distributed by the Satellite Master Antenna Television systems. Members may recall that a Subcommittee has been formed to study the Regulation. The Subcommittee reported to the House Committee on the Regulation on 8 October 1999 and recommended that the Regulation be supported.

INTRODUCTION

At the meeting of the Executive Council on 5 October 1999, the Council ADVISED and the Chief Executive ORDERED that the Fire Services Department (Welfare Fund) Regulation, the Police Force (Welfare Fund) Regulation, Prison (Amendment) Rules 1999, the Immigration Service (Welfare Fund) Regulation and the Customs and Excise Service (Welfare Fund) Regulation, at the Annex, should be made.

BACKGROUND AND ARGUMENT

2. Five disciplined services Ordinances, i.e. the Fire Services Ordinance, the Police Force Ordinance, the Prisons Ordinance, the Immigration Service Ordinance and the Customs and Excise Service Ordinance, and their subsidiary legislation have to be amended in order to regularize the sources of income and formalize operational arrangements for the welfare funds of these disciplined services. Details can be found in the Legislative Council Brief on the Disciplined Services Welfare Funds Legislation (Amendment) Ordinance 1999 issued on 28 January 1999.

THE ORDINANCE

3. Amendments to the five disciplined services Ordinances were introduced under the Disciplined Services Welfare Funds Legislation (Amendment) Bill 1999 and passed by the Legislative Council on 16 July 1999. The Bill received the assent of the Chief Executive on 22 July 1999.

REGULATIONS AND RULES

- 4. The Regulations and Rules at the Annex repeal and re-enact provisions of the existing subsidiary legislation that relate to the five disciplined services welfare funds in consequence of the enactment of the Disciplined Services Welfare Funds Legislation (Amendment) Ordinance 1999. The Regulations and Rules will -
- (a) replace references to the heads of the five disciplined services departments with references to the corporations on those heads being constituted corporations for the purpose of the welfare funds;
- (b) replace the current outdated provision relating to the investment of surplus money held in the welfare funds;
- (c) provide for the payment of interest on loans made from the welfare funds; and
- (d) substitute for the current requirement for tabling the audited statement of accounts prepared for the welfare funds a requirement that the audited statement of accounts must be tabled in the Legislative Council within three months after the date on which the corporation receives it from the Director of Audit, or within such further period as the Chief Executive allows in a particular case.

8. The former Legislative Council Panel on Security was briefed in December 1996 and supported improvements to the welfare funds of the five disciplined services.
