Introduction of Government Bills

We have just completed a review of the progress we have made in the introduction of government bills into LegCo in the current legislative session.

As at 1 March, we have introduced a total of 41 bills, a list of which is at the Annex for Members' easy reference. We expect to introduce another two to three pieces of legislation at the LegCo meeting on 15 March. To enable Members to have sufficient time to scrutinize the bills already introduced, we do not intend to introduce any more bills after 15 March, unless it is absolutely essential and urgent. For any exceptional items of this nature, we shall consult the relevant Panels as far as possible prior to introduction.

We appreciate the hard work and contributions made by Members in the scrutiny of government bills. Legislative work for Members in the few months ahead will continue to be heavy and we look to Members for continued co-operation. Please rest assured that we would continue to work closely with Members to facilitate their scrutiny of the bills.
