### Paper for the House Committee Meeting of the Legislative Council on 16 June 2000

Legal Service Division Further Report on Adaptation of Laws (No. 32) Bill 1999

Members may recall that the Legal Service Division made a report to the House Committee on 24 September 1999 on the Bill (LC Paper No. LS255/98-99 refers). Annexes A and B of the report are attached for Members' ease of reference. Members agreed to defer decision on the Bill pending clarifications from the Administration.

- 2. Section 4 of Schedule 17 of the Bill proposes to repeal the reference to "English" in section 12(1)(a) of the English Schools Foundation Ordinance (Cap. 1117) which prescribes that contracts on behalf of the English Schools Foundation shall be made under the common seal of the Foundation if required by English law to be under seal. The proposed adaptation would be deemed to have come into operation on 1 July 1997. In this respect, the Administration has clarified that:
  - (a) the definition of "law" in section 3 of the Interpretation and General Clauses Ordinance (Cap. 1) would apply, i.e. any law for the time being in force in, having legislative effect in, extending to, or applicable in Hong Kong;
  - (b) no contract has been made under the common seal of the Foundation since 1 July 1997; and
  - (c) all contracts made by the Foundation since 1 July 1997 are entered into in accordance with the advice of lawyers that they are not required by English law nor the law in force in Hong Kong to be made under seal.
- 3. The Administration proposes to withhold the adaptation of "Crown" where the Hong Kong Council for Academic Accreditation is expressed as not to be regarded as a servant or agent of the Crown or as enjoying any status, immunity or privilege of the Crown. This amendment is made along the same line as the amendment proposed to the Adaptation of Laws (No. 16) Bill 1999.

- 4. Copies of the Administration's reply and the proposed Committee Stage amendment are at Annex C.
- 5. According to the Administration, all affected bodies have been consulted on the Bill and agreed to the proposed amendments. Subject to Members' views, the Bill is ready for resumption of Second Reading debate.

### B. Repeals

- 1. Section 7 of Schedule 10 of the Bill proposes to repeal "of the Colony" when referring to the general revenue in section 21 of the Education Scholarships Fund Ordinance (Cap. 1085).
- 2. Section 3 of Schedule 12 of the Bill proposes to repeal "the Colony of" when referring to Hong Kong in Rule 9(2) of the Munsang College Rules (Cap. 1094 sub. leg.).
- 3. Section 12(1)(a) of the English Schools Foundation Ordinance (Cap. 1117) prescribes that contracts on behalf of the Foundation shall be made under the common seal of the Foundation if required by English law to be made under seal. Section 4 of Schedule 17 of the Bill proposes to repeal the reference to "English".

Under these provisions, the relevant corporations have the power to invest moneys on deposit in any bank in Hong Kong or elsewhere within the British Commonwealth, or in Hong Kong or British Commonwealth government bonds, or on mortgage of any land, buildings, messuages or tenements in the Colony, or in or on debentures, debenture-stocks, stocks, funds, shares, or securities of any corporation or company carrying on business in Hong Kong or elsewhere within the British Commonwealth. References to the British Commonwealth are repealed for the purposes of section 2A(2)(b) of Cap.1 which specifies that provisions conferring a privilege on the British Commonwealth countries shall have no further effect.

#### Adaptation of Laws (No. 32) Bill 1999

Thank you for your letter of 14 September 1999 seeking clarifications on the Adaptation of Laws (No. 32) Bill 1999. Our reply is set out below -

#### Section 4 of Schedule 17

- (a) Yes.
- (b) & (c) Since 1 July 1997, the English Schools Foundation (ESF) has only entered into contracts which are not required by the English law nor Hong Kong law to be made under seal. All these contracts are entered into in accordance with the advice of ESF's lawyers. Our proposal of this specific provision taking retrospective effect from 1 July 1997 therefore will not cause any operational difficulties or legal problems.

#### Section 15 of Schedule 22

We understand that, as agreed between the Health and Welfare Bureau and the Bills Committee, the adaptation of the non-immunity provision has been taken

out in the Adaptation of Laws (No. 16) Bill 1999. We will introduce a similar committee stage amendment (CSA) to take out the proposed adaptation of the non-immunity provision in section 24 of the Hong Kong Council for Academic Accreditation Ordinance (Cap 1150). A draft CSA is attached for your reference.

#### Public consultation

All affected bodies have been consulted on the Bill, and agreed to the proposed amendments.
