Paper for the Legislative Council Subcommittee on Payment of Honoraria to Government Boards and Committees

Purpose

At the request of the Subcommittee, we have collated from bureaux more details on the payment of honoraria to non-official members of boards and committees under their purview. This paper provides the requisite information.

Background

2. At the Subcommittee's meeting on 22 February 2000, we informed Members of the principles relating to the payment of honoraria to non-official members of Government boards and committees. We also provided a list of those boards and committees whose members are receiving honoraria, some approved by the Secretary for the Treasury under delegated authority from Finance Committee while others were specifically approved by Finance Committee on a case-by-case basis. Members requested the Administration to provide details on the payment of honoraria in respect of all boards and committees appointed by the Government to facilitate a more comprehensive review. Specifically, Members requested that information with regard to those boards and committees which are not funded by Government should also be included.

Collation of Information

3. Having consulted the LegCo Secretariat on the extent of information required, we invited all bureaux to file returns in respect of boards and committees appointed by the Government under their purview. The Executive Council, the Legislative Council and the District Councils and their committees are excluded. To meet Members' specific request, information in respect of boards or governing bodies of public bodies that are not funded by Government are included, for example, the MTRC, KCRC, Land Development Corporation, etc.. The information collated covers the number of members on the board/committee, the frequency of their meetings and the current arrangements for remuneration/honorarium. This information, as appropriately consolidated, is at the <u>Appendix</u>.

Analysis

- 4. In summary, based on the information so gathered, there are 586 boards, committees, councils, panels, advisory groups, commissions, authorities and tribunals with a total of 10 528 non-official members. Of these, only 65 involving 1 991 members are remunerated. Apart from a few exceptions, these Members receive a modest remuneration on a per attendance basis
- 5. As observed by Members at the last meeting, only a small proportion of non-official members serving on Government-appointed boards and committees are receiving some sort of remuneration. However, the fact is this large number of boards and committees carry varied functions and duties; the workload and hence demand on their time also varies considerably. We believe that the present approach of bureaux considering the need for remuneration against the general principles previously endorsed by Finance Committee remains a pragmatic approach. As proposed at the last meeting of the Subcommittee, we are happy to remind Bureau Secretaries of the general principles of remunerating non-official members of Government boards and committees and urge them to make a conscious effort to review whether the granting of an honorarium is justified. We will do so after taking into account the views of the Subcommittee.
