Designation of officials for attendance at meetings of the Legislative Council, its Committees and Subcommittees

On 31 December 1998, the Chief Executive signed two instruments to designate officials to attend meetings of the Legislative Council, its Committees and Subcommittees under Article 62(6) of the Basic Law (copies at Annex A). These instruments supersede those signed by the Chief Executive on 26 June 1998.

- 2. Members may wish to note that in the current instrument designating officials to attend meetings of Committees and Subcommittees of the Legislative Council, the following persons included in the previous instruments dated 26 June 1998 (copies at Annex B) are now excluded:
 - (a) The Judiciary Administrator and all directorate officers in the Office of Judiciary;
 - (b) The Ombudsman and all directorate officers in the Office of the Ombudsman;
 - (c) Chairperson and all directorate officers of the Equal Opportunities Commission;
 - (d) Privacy Commissioner for Personal Data, all directorate officers and the Legal Adviser in the office of the Privacy Commissioner for Personal Data:

- (e) The Chief Executive of the Hospital Authority, all deputy directors, all hospital chief executives;
- (f) Chairperson of the Housing Authority; and
- (g) Chairperson and all Executive Directors and the Chief Counsel of the Securities and Futures Commission.

According to the Director of Administration, the Department of Justice has advised that designation under Article 62(6) of the Basic Law should only include persons who are members of the Administration and responsible persons of statutory bodies should not be designated to speak on behalf of government. The designation of officials under Article 62(6) of the Basic Law has therefore been revised accordingly.

DESIGNATION OF OFFICIALS FOR ATTENDANCE AT MEETINGS OF THE LEGISLATIVE COUNCIL, ITS COMMITTEES AND SUBCOMMITTEES

By virtue of the power vested in the Government of the Hong Kong Special Administrative Region by Article 62(6) of the Basic Law, I, TUNG CHEE-HWA, Chief Executive of the Hong Kong Special Administrative Region, being the Head of the said Government and acting in its name and on its behalf, hereby designate generally the officials who from time to time either substantively occupy or act in the posts specified in the schedule below to attend meetings of the Legislative Council, or of any committee or subcommittee thereof, and to speak thereat on behalf of the said Government, as and when it may appear necessary or expedient to any such officials for the due and proper discharge of the responsibilities attaching to his office or as I may from time to time direct.

DESIGNATION OF OFFICIALS FOR ATTENDANCE AT MEETINGS OF COMMITTEES AND SUBCOMMITTEES OF THE LEGISLATIVE COUNCIL

By virtue of the power vested in the Government of the Hong Kong Special Administrative Region by Article 62(6) of the Basic Law, I, TUNG CHEE-HWA, Chief Executive of the Hong Kong Special Administrative Region, being the Head of the said Government and acting in its name and on its behalf, hereby designate generally the officials who from time to time either substantively occupy or act in the posts specified in Schedule 1 below to attend meetings of committees and subcommittees of the Legislative Council and to speak thereat on behalf of the said Government (but not at meetings of the Legislative Council itself unless specifically designated so to do by me) as and when directed to do so either by me or by some other officials whom I hereafter authorise.

This authorisation shall remain in force, unless earlier revoked by me, until such date as the term of office of the Legislative Council shall end or of such date as the Council shall be dissolved pursuant to Article 50 of the Basic Law.
