# Green Groups' Recommendations to LegCo EA Panel on SSDS Review

The green groups welcome the initiation of a new review for the Strategic Sewage Disposal Scheme (SSDS), and consider it a very good opportunity to re-examine the scheme closely and formulate a truly cost-effective, environmentally- friendliness, and sustainable sewage strategy for Hong Kong. At this point, we would like to make the following recommendations for the forthcoming expert review:

- 1. The review should aim at formulating a sustainable sewage strategy for Hong Kong. which is capable of coping with Hong Kong's ever growing population and sewage generation, and at the same time being environmentally and financially sustainable. Particularly, instead of centralised disposal of sewage, the strategy should aim at localised treatment at source.
- 2. The forthcoming review should be done in a holistic manner. It should not be limited to Stage II to IV, or to technical feasibility of the options currently adopted, but should also include all the aspects mentioned above. The green groups think it is absolutely worth reviewing the entire SSDS, taking into account experience in Stage I, changes in population forecast (and thus sewage generation forecast) and in future hydrology, and new technology available.
- **3.** The review panel should include a wide range of experties. Besides sewage and tunnel experts, it should also contain marine ecologists, economists, planners, specialists in Biological Nutrient Reduction, hydraulic and water quality monitoring experts, as well as representatives from environmental groups, so that all relevant interests can be represented in the panel and SSDS can be reviewed holistically.
- 4. Nominations from concerned groups and professional bodies should be considered.

- 5. The reviewers to be appointed should have no vested interest in the result of the forthcoming review. All panelists should be requested to declare interest before being appointed.
- **6.** The review process should be as transparent as possible. The review process and public consultation should be conducted in open meetings, and all papers and information requested by the EA Panel should be accessible to consulted parties such as EA Panel members, academics, professionals and green groups.

The green groups are in the view that the above recommendations are crucial in formulating a sewage strategy which can cope with our current and future problem of sewage disposal and marine water quality. We sincerely hope that you consider these recommendations during the formation of the forthcoming IRP.

## Views on SSDS and forthcoming review from

#### academics, professionals, green groups and interested individuals

Friends of the Earth (HK) is conducting a questionnaire survey to collect views on Hong Kong Strategic Sewage Disposal Scheme (SSDS) and expectations of the terms of the forthcoming review from concerned individuals. Interim results of the survey and more recommendations from green groups are summarised as follows:

**Panel of experts**: the forthcoming IRP should have a wide representation of expertise in the forthcoming panel, including sewage treatment, tunnelling/geotechnical, economics, environmental management and policy, environmental groups, marine ecology, and hydraulic and water quality monitoring.

**Steering Group**: a steering group with representatives from the LegCo Panel of Environmental Affairs, Advisory Council on the Environment, relevant policy bureaux should be formed to oversee the review.

**Scope of review**: All stages from I to IV should be reviewed. The sustainability, environmental impact, financial viability and the engineering feasibility of SSDS should be looked into. Alternatives to the current design, like higher treatment level, distributed treatment, and wastewater recycling technology, should be considered.

**Transparency**: the public should be kept informed about the progress and the result of the review. All panelists should be requested to declare interest before being appointed.

**Public involvement**: LegCo members, professionals and academics should be consulted in upon appointment of the forthcoming IRP. And the public should nominate panel expert for the forthcoming IRP, and should be kept informed about the progress and the result of the review. Parties to be consulted during the review should have full access to information.

**Suspension of work**: Works of Stage I should be stopped to enable an thorough review of the entire SSDS.
